## SITE REVIEW AND DOCUMENTATION SAMPLING

### Site Review

PREA Standard 115.401 (h) states, "The auditor shall have access to, and shall observe, all areas of the audited facilities." In order to meet the requirements in this Standard, the site review portion of the onsite audit must include a thorough examination of the entire facility. The site review is not a casual tour of the facility. It is an active, inquiring process that includes talking with staff and inmates to determine whether, and the extent to which, the audited facility's practices demonstrate compliance with the Standards. The Stutsman County Correctional Center written policy 6-10 mandates zero tolerance toward all forms of sexual abuse and sexual harassment. The Stutsman County Correctional Center Jail Administrator/PREA Coordinator has sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards and has done an exceptional job in managing the Stutsman County Correctional Center's PREA compliance efforts. The Jail Administrator/PREA Coordinator, the Deputy Administrator, the Administrative Officer and the Lieutenant who is assigned as the PREA Compliance Manager work as a cohesive team to ensure that every standard is in compliance. They are extremely conscientious and ensure that the zero-tolerance policy is a part of the culture within the Stutsman County Correctional Center.</p>

	<p data-bbox="242 210 451 237"><b>Auditor Discussion</b></p> <p data-bbox="242 271 1493 831">The Stutsman County Correctional Center has developed, documented, and made its best efforts to comply on a regular basis with a staffing plan that provides for adequate levels of staffing. The auditor reviewed policy, the staffing plan, organizational structure, verified the staffing levels through the schedule that was provided and verified through direct observation while on the facility tour. The facility has two primary shifts – a 12-hour dayshift from 7am to 7pm and a 12-hour overnight shift from 7pm to 7am. There are various other shifts ran dependent on needs for the weekday such as training, transports, court, et cetera. There is a minimum of three staff on each shift, but typically during the weekday dayshift there are four staff on the shift. Each shift typically has one shift sergeant, one control room staff and one housing custody staff. Other posts that may be added are an intake/rover officer and a transport officer. There is always one female officer available to conduct searches of female inmates. There have been no deviations from the staffing plan. The facility is also required to notify the North Dakota Department of Corrections if they drop below their minimum staffing level. They use video monitoring, electronic door monitoring and an intercom system to protect inmates against sexual abuse. The jail administrator completes an annual review to assess, determine, and document whether adjustments are needed to the staffing plan. Video Monitoring is included when they review their staffing plan each year. During this time, they review the staffing plan to see whether adjustments are needed to the staffing levels and discuss camera coverage and the need for any changes. The facility has 72 cameras of which 50 are specific to jail operations. The other cameras are external to the building and building areas external to the jail. The auditor recommended adding more detailed statements to the staffing plan regarding camera coverage.</p> <p data-bbox="242 864 1493 1093">Higher-level supervisors conduct and document unannounced rounds. These rounds are documented in their computerized jail management system under a supervisory log entry “Unannounced PREA round and lists the administrator staff member’s name who conducted the round. The unannounced rounds include all shifts to include the night shift and weekends. An administrator has the assigned round duty for three months and during that time must ensure that there are two rounds per month with a night shift round and one day shift round. One of the rounds must be on a weekend or a holiday. Once at the sallyport, the administrator hits the intercom button to gain access to the jail. This is the most notice given to jail staff that an administration staff is arriving.</p>

The Stutsman County Correctional Center trains line staff in the proper methods to conduct cross-gender pat-down searches, and searches of transgender and intersex inmates, in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs. The auditor verified this through a review of policy 5-07 Clothed and Unclothed Searches, through interviews with staff and inmates and through a review of the training files. In the event a cross-gender search is needed, the Stutsman County Correctional Center will document all cross-gender strip searches and cross-gender visual body cavity searches. There has been no cross-gender searches for this audit review period. All interviews with both inmates and staff confirmed the practice of male staff searching male inmates and female staff searching female inmates. The facility prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures for transgender or intersex inmates.</p> <p data-bbox="229 658 1509 938">The Stutsman County Correctional Center has policies and procedures that enable inmates to shower, perform bodily functions, and change clothing without staff of the opposite gender viewing them in a state of undress except in exigent circumstances or when such viewing is incidental to routine cell checks. Such policies and procedures require staff of the opposite gender to announce their presence when entering an inmate housing unit. The auditor reviewed policy 6-10 (PRE) Prison Rape Elimination Act of 2003 and directly witnessed announcements while on the facility tour and throughout the audit and the practice was confirmed through both staff and inmate interviews. All camera views were adequately blocked to ensure that inmates have privacy to toilet. Shower stalls have curtains and inmates are required to change clothing during the shower process.</p>

The Stutsman County Correctional Center inmate handbook and posters are also in Spanish, as this is predominantly the other language encountered at this facility. The facility has a contract with the Language Line, an interpreter service, to include sign language interpretation. They also utilize the North Dakota School for the Deaf and Hard of Hearing for freelance interpreters. The facility does not use inmates to interpret for other inmates. They have instructed all staff in the use of these procedures and provided the numbers for their 24-7 interpretation service in easily accessible areas for staff. The interpretive services can assist in the intake process, screening process, education on how to report and if need be, translate during the investigative process. Staff work with inmates who may have trouble reading or comprehension due to a disability or cognitive impairment. They read the information and explain it to them at a level they able to understand. These procedures were confirmed during staff interviews, through a review of their interpretive service contract, a review of their PREA policy 6-10 and policy 6-01 Inmates with Disabilities.</p>

The auditor reviewed a random sampling of employee files and found the necessary background checks were ran prior to employment/service and that they a background check had been ran within the last five years. Stutsman County Correctional Center performs a background check at least every five years of contractors who may have contact with inmates.</p> <p data-bbox="231 459 1508 875">The Stutsman County Correctional Center does not hire, promote, or enlist the services of any employee or contractor who may have contact with inmates, who has engaged in sexual abuse in any criminal justice facility, has been convicted of engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse; or has been civilly or administratively adjudicated to have engaged in the activity described above. These questions are asked of perspective applicants during the hiring process. These questions are asked again during the annual review process. A reference check is made of former institutional employers regarding substantiated sexual misconduct by applicants who had previous employment history in an institutional setting. The Stutsman County Correctional Center hiring, and promotional processes were confirmed by a review of employment and contractor records and an interview with the jail administrator who oversees all employment actions. The Stutsman County Correctional Center provides information on substantiated allegations of sexual abuse or sexual harassment involving a former employee upon receiving a request from an institutional employer for whom such employee has applied to work.</p>

These services are outlined in a MOU with the center. As requested by the victim, a victim advocate accompanies and supports the victim through the forensic medical examination process and investigatory interviews and are provide emotional support, crisis intervention, information, and referrals.</p> <p data-bbox="229 479 1508 806">The Stutsman County Correctional Center has five trained facility investigators to conduct administrative investigations. The investigators have completed the PREA investigator training provided either by North Dakota Department of Corrections and Rehabilitation or online courses through the National Institute of Corrections or both. These courses are specific to sexual abuse investigations in confinement settings. All criminal allegations are turned over to Stutsman County Sheriff's Department for investigation. In some instances, the Sheriff's office may call in the North Dakota Bureau of Investigation to conduct the investigation. The criminal investigator immediately reaches out to the state's attorney office once there is evidence of sexual abuse. The Stutsman County Sheriff's Office evidence protocol is based on the North Dakota Sexual Assault Evidence Collection Protocol 5th edition adapted from the Sexual Assault Protocol developed by the United States Department of Justice.</p>

When an inmate initially signs on to the kiosk within their housing unit the screen displays PREA information regarding their rights to be free from sexual abuse and sexual harassment, to be free from retaliation for reporting such incidents and methods of reporting. The inmate must acknowledge reading it before having access to the kiosk. The auditor requested an inmate open the kiosk so that the auditor could view the information available to them regarding PREA. The interviews confirmed that inmates were well aware of how to report and were familiar with multiple ways to report. The training is documented through the inmates' signature on an acknowledgement form. The inmates stated they feel safe and that their staff treat them respectfully and professionally. Many reported that if they needed to report anything they would report it directly to their staff but were aware of the other methods.</p>

The investigators have completed the PREA investigator training provided either by North Dakota Department of Corrections and Rehabilitation or online courses through the National Institute of Corrections or both. These courses are specific to sexual abuse investigations in confinement settings. All criminal allegations are turned over to the Stutsman County Sheriff's Department for investigation. In some instances, the investigation is turned over to the North Dakota Bureau of Investigation. Stutsman County Correctional Center publishes its investigative policy on its website <a href="https://www.stutsmancounty.gov/files/PREA-policy-and-procedures.pdf">https://www.stutsmancounty.gov/files/PREA-policy-and-procedures.pdf</a>.</p>

	<p data-bbox="244 208 453 237"><b>Auditor Discussion</b></p> <p data-bbox="244 271 1490 501">The medical staff have completed specialized training through the National Institute of Corrections PREA Learning Center. The nurses have completed both the courses for medical professionals and mental health professionals. During the interview the RN was knowledgeable about the appropriate response for transporting the inmate to the hospital for sexual assault forensic exams and protecting evidence to aid in the prosecution of a sexual assault. All providers have also received in-house PREA training mandated for all employees of the Stutsman County Correctional Center. The Stutsman County Correctional Center does not provide in-house mental health services. Inmates are referred to a provider at the Human Services Center for mental health care.</p>

Intake screenings take place usually within a few hours of arrival, but never exceed 72 hours. The Deputy Jail Administrator reassesses all inmates within 30 days of arrival, when there is an incident, or upon request to ensure the inmate is safely housed based on all information. The Jail Administrator reviews all re-assessments. Inmates who are transgender or intersex are reassessed at a minimum of every six months.</p>

In deciding whether to assign an inmate who is transgender or intersex to a housing unit for male or female inmates, and in making other housing and programming assignments, Stutsman County Correctional Center considers on a case-by-case basis whether a placement would ensure the inmate's health and safety, and whether the placement would present management or security problems. An inmate who is transgender or intersex own views with respect to his or her own safety would be given serious consideration. All inmates shower in separate shower stalls at this facility. Stutsman County Correctional Center does not place lesbian, gay, bisexual, transgender, or intersex inmates in dedicated units solely based on such identification. An inmate's risk level is reassessed when warranted due to a referral, request, incident of sexual abuse, or receipt of additional information that bears on the inmate's risk of sexual victimization or abusiveness. Inmates are not disciplined for refusing to answer, or for not disclosing complete information in response to, questions asked.</p>

	<p>The Stutsman County Correctional Center considers the least upsetting placement for the alleged victim. Staff interviews confirmed that inmates at high risk for sexual victimization are not placed into protective custody unless the inmate cannot be protected by any other means. A review of status for protective custody is completed at a minimum of every 30 days. They have not placed any alleged inmate victims of sexual abuse or sexual harassment in involuntary segregated housing.</p>

	<p data-bbox="240 208 451 237"><b>Auditor Discussion</b></p> <p data-bbox="240 271 1490 562">The auditor interviewed administrators, staff, and inmates, reviewed policy and toured the facility. The Stutsman County Correctional Center provides multiple internal ways for inmates to privately report sexual abuse and sexual harassment, retaliation by other offenders or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Staff accepts reports made verbally, in writing, electronic requests or grievances or electronic PREA reports through their kiosk system, anonymously, and from third parties and promptly documents any verbal reports. At the time of the on-site portion of the audit the Stutsman County Correctional Center was utilizing external entities to include the Stutsman County Sheriff's office or inmates my call or write to Safe Shelter, the local rape crisis center. Bureau of Prisons and US Marshall's inmates can also write to the Office of the inspector General.</p> <p data-bbox="240 595 1490 987">The auditor informed the facility that the Department of Justice legal interpretation of this standard through a FAQ posted on the PREA Resource Center website dated 6Feb2020 states that typically a rape crisis center and other victim service providers should not be used for this purpose. They have a mission of providing support and services to victims. Under federal law, if such centers and providers are funded at least in part, either as a direct recipient or as a subrecipient of certain federal grants they are required to keep identifying information about victims confidential. The only limited exceptions to this requirement are when the victim signs an informed, written, time-limited release, or when release is required by a legal mandate. This requirement to keep confidential identifying information about victim's conflicts with the requirement of PREA Standard 51(b) to be able to immediately forward reports of sexual abuse and sexual harassment to agency officials. The Stutsman County Sheriff's Department cannot be an external reporting entity because the Sheriff operates both the Stutsman County Correctional Center and the Stutsman County Sheriff's Department and therefore is not considered an external entity. The auditor discussed different options that they should pursue to find an alternate external reporting agency for inmates. The auditor discovered that all outgoing phone calls require an inmate Personal Identification Number (PIN). The Department of Justice legal interpretation of this standard through a FAQ posted on the PREA Resource Center website dated 6Feb2020 states that PREA Standard 51(b) requires agencies to "provide at least one way for inmates to report abuse or harassment to a public or private entity or office that is not part of the agency, and that is able to receive and immediately forward inmate reports of sexual abuse and sexual harassment to agency officials, allowing the inmate to remain anonymous upon request." The term "anonymous" as used here means that the inmate must have the ability (at the inmate's request) to keep his or her identity protected from disclosure to agency and facility personnel. However, the external reporting entity must be able to immediately forward the substance of the allegation back to agency officials. Also, when the inmate does not affirmatively request anonymity, the external reporting entity must be able to immediately report the entirety of the allegation back to agency officials. Inmates may request anonymity – that their identity will not be provided to agency personnel." However, inmates are required to enter their identification number prior to gaining access to any call, and facility signage above the phones indicates that "all calls are subject to monitoring and recording by facility staff."</p> <p data-bbox="240 1886 1458 1942">This does not satisfy PREA Standards 115.33 or PREA Standard 115.51(b) because inmates are provided with conflicting information, and there is no reasonable basis to believe that the State OIG permits anonymity.</p> <p data-bbox="240 1975 1490 2161"><b>CORRECTIVE ACTION:</b> The auditor required an alternate way for inmates to report external to the Stutsman County Correctional Center, and that the external entity will immediately forward any reports of sexual abuse or sexual harassment to the Stutsman County Correctional Center Jail Administrator and allow the inmate to remain anonymous upon request. To verify that an alternate external reporting entity has been put in place, the auditor required an agreement signed by the external entity that includes a statement that the inmate can remain anonymous upon request. On May 19, 2022, the facility administrator signed an MOU with the Jamestown Police Department that provides both their phone number and mailing</p>

address to be used for inmates to communicate with them regarding allegations of sexual abuse or sexual harassment. The Jamestown Police Department will immediately forward the reports to the Stutsman County Corrections Center administrator, deputy administrator, lieutenant or on duty sergeant, assuring the anonymity of the inmate if requested by the inmate.

The auditor required modifications to all training documents regarding how to report to the new external reporting entity and listing Safe Shelter under the heading "Victim Support/Advocacy" not under the reporting heading. This includes modifications to all posters, inmate intake/orientation training materials, and inmate comprehensive training materials, and reporting information in any handouts or on the kiosk. To verify that training documents have been modified, the auditor requires dated photographs of posters throughout the facility, photographs of modified information on the kiosk, and copies of any modified training documents to include curriculums, signature sheets, or handouts. On May 19, 2022, the jail administrator provided the auditor revised "Inmate Orientation Information" form, a revised Inmate Handbook, a revised inmate PREA poster, photographs of the new poster posted throughout the facility and photographs of the revised reporting information posted on the inmate kiosk.

The auditor required that a PIN not be used for inmate calls to the external reporting entity, as an individual PIN can be traced back to a specific inmate who called the external reporting entity. To verify that a PIN number is not used for these calls, the auditor required a copy of an email or letter signed and dated by the company providing their inmate phone service that these calls do not require an inmate PIN, are free calls and not recorded. On May 19, 2022, the jail administrator provided a letter signed by the president of TurnKey Corrections which states they upgraded the facility's phone service to allow for anonymous, free, non-recorded PREA reporting that does not require the use of an in PIN.

	<p>Inmates may file a grievance or administrative remedy regarding allegations of sexual abuse or sexual harassment. All allegations of sexual abuse or sexual harassment when received by staff, would immediately result in an administrative or criminal investigation. There is no time limit on when an inmate may submit a grievance regarding an allegation of sexual abuse. The PREA Policy (pages 23 and 24), the inmate handbook (pages 13 through 15) and the inmate information on the kiosk outline the administrative remedy process. Inmates are not required to use an informal grievance process or to otherwise attempt to resolve with staff an alleged incident of sexual abuse. A Stutsman County Correctional Center inmate may file an emergency grievance alleging an inmate is subject to a substantial risk of imminent sexual abuse. Staff will immediately forward such a grievance to the jail administrator for which immediate corrective action will be taken.</p>

	<p data-bbox="229 192 1508 255"><b>Auditor Discussion</b></p> <p data-bbox="229 255 1508 582">On February 28, 2022, Stutsman County Correctional Center entered into a new Memorandum of Understanding with Safe Shelter in Jamestown for outside confidential support services. Phone numbers and mailing addresses are provided, in English and Spanish, on the inmate kiosk, in the inmate handbook, in the brochure the inmates receive during intake and are posted throughout the housing areas. The auditor performed a test call to Safe Shelter from the housing unit. The call required a PIN, but it did state that the call would not be recorded. The hotline operator confirmed the MOU and the services that they provide to the jail. She stated that they have nothing that gives them any concerns about inmate sexual safety at this facility. Stutsman County Correctional Center has a contract for holding detainees and they do have it posted to provide persons detained solely for civil immigration purposes information on how to contact consular officials or the Department of Homeland Security.</p>

	<p>The Stutsman County Correctional Center website provides information on how an individual can make a third-party report. Third parties can report sexual abuse and sexual harassment to any facility staff member. In addition, there are posters in the visit area. Stutsman County Correctional Center has not received any third-party reports. Interviews with staff and inmates confirm that staff and inmates are aware that third-party reporting options are available.</p>

	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The Stutsman County Correctional Center PREA Policy requires all staff to immediately report any knowledge, suspicion, or information regarding an incident of sexual abuse or harassment, or retaliation toward inmates or staff for reporting any such incident, and for staff not to reveal any information related to a sexual abuse report to anyone other than the extent necessary. Staff confirmed understanding of this policy during the interview process. Staff can report by any means (writing, verbally or telephoning) to any supervisor. They may also report by writing directly to the jail administrator and may remain anonymous. This is reiterated to staff through posters located throughout the facility.</p>

If such an allegation is received by them from another facility, an investigation will be initiated immediately. Both notifying other agencies and receiving notifications is documented. There have been ten incidents reported regarding sexual abuse that occurred at another facility. There have been no incidents reported to the Stutsman County Correctional Center administrators by other facilities. Compliance with this standard was confirmed through a review of the PREA policy, a review of notification documentation and through interviews with both the Sheriff and the Jail Administrator.</p>

Staff stated they would first separate the alleged victim and the alleged abuser. The alleged victim would be taken to a more private area, typically the medical office. They would encourage the alleged victim to protect any evidence by not washing, brushing teeth, changing clothes, using the restroom, drinking, or eating until the physical evidence can be collected by the SANE. They would remove the alleged abuser to segregated housing and again, not allow them to not wash, brush teeth, change clothes, use the restroom, drink, or eat until the physical evidence can be collected by the SANE. The staff would notify the shift supervisor, secure, and protect any physical area where there may be evidence to be collected. They will contact medical staff or take them to the nearest hospital to provide immediate medical care if appropriate. This was also confirmed through posters titled "Coordinated Response to Sexual Abuse" in which the first two items are directed to the first responder to assist them with their first responder duties.</p>

	<p data-bbox="244 210 453 237"><b>Auditor Discussion</b></p> <p data-bbox="244 271 1493 528">The Stutsman County Correctional Center PREA policy covers the coordinated response to sexual abuse. Training covers the coordinated response plan. Interviews with correctional officer staff, supervisors, the nurse, the investigator, the victim advocacy agency, and the Jail Administrator/PREA Coordinator confirmed that that the procedures listed in their coordinated response plan are being held to. The auditor viewed posters titled "Coordinated Response to Sexual Abuse" that are posted in staff areas. These posters cover duties of the first responders, shift supervisors, medical staff, the investigator, the PREA Compliance Manager, and the PREA Coordinator. The coordination with the SANE exam is listed under the medical staff and the PREA Coordinator is responsible for reviewing actions of any of the above and documenting those actions. This poster is formatted in an easy-to-read flow chart.</p>

<b>115.66</b>	<b>Preservation of ability to protect inmates from contact with abusers</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<p data-bbox="244 210 453 237"><b>Auditor Discussion</b></p> <p data-bbox="244 271 1485 465">This auditor's review of the PREA policy and interviews of the Sheriff and the Jail Administrator verified that the Stutsman County Correctional Center has a disciplinary process that allows for staff discipline if staff are involved in any type of sexual misconduct or for violating any agency sexual abuse or sexual harassment policies. Discipline can include reassignment of a post, administrative leave during an investigation, discipline for actions or failures to act that could lead to sexual misconduct by others and dismissal or termination from employment. The Stutsman County Correctional Center staff are not represented by any union agreement.</p>

	<p>The Stutsman County Correctional Center PREA Policy covers all elements of this standard. The lieutenant is designated to monitor for retaliation up to a 90-day period or for as long as needed. The lieutenant checks in with staff and/or inmates involved in the report. He will monitor behavior, staff call-outs to work, attitude, and disciplinary reports. He will document any findings on the PREA Retaliation Monitoring form that is attached to the investigative file with any notes regarding any retaliation or steps taken to ensure against retaliation.</p>

After interviewing the Jail Administrator, the lieutenant, and inmates, there were no instances of using segregation to protect an inmate who had alleged to have been sexually abused. Staff stated segregated housing would only be used at the request of the inmate. There are multiple housing options available to provide adequate separation for the protection of an inmate. The standard practice would be to place the suspected abuser in segregated housing.</p>

The facility investigated eleven allegations in 2021 and five allegations for 2022 thus far. The incidents were properly investigated as outlined by their policy and PREA standards. All investigators have received specialized training to conduct sexual abuse investigations. Administrative investigations include efforts to determine whether staff actions/failures contributed to the abuse. The investigations are documented through written reports and include physical/testimonial evidence, credibility reasoning assessments and investigative facts and findings. All written reports will be retained for at least seven (7) years from inmate(s) discharge. Investigations will not be terminated due to the departure of an alleged abuser or victim. The facility will cooperate with outside investigators and will remain informed of the investigation progress.</p>

	<p>The Stutsman County Correctional Center PREA policy stipulates no standard higher than a preponderance of evidence will be used to determine incidents of alleged sexual abuse or sexual harassment during an administrative investigation. The auditor interviewed the investigators and reviewed investigative files and was confident that this facility uses no standard higher than a preponderance of the evidence. The facility takes appropriate actions following an investigation based on the outcome of the investigation.</p>

If a sexual misconduct allegation is confirmed, the inmate will be informed of the abuser's employment/volunteer/contractor status; and as appropriate of an indictment/conviction. Interviews with the Jail Administrator confirmed practices involving all standard components were in place. The auditor reviewed investigative files and found documented evidence that the inmate is made aware of the outcome. Outcome to the inmate is made on the form "Notice of PREA Investigation Status".</p>

	<p>The Stutsman County Correctional Center PREA policy requires that staff members who have violated sexual abuse, sexual harassment or retaliation policies are subject to disciplinary sanctions. In reviewing investigative files and conducting interviews with the Sheriff and the Jail Administration it was confirmed that agency policy is followed, and appropriate disciplinary measures are used commensurate with the violation. When criminal acts are suspected, it is reported to law enforcement.</p>

There have been no reported instances of sexual harassment or sexual abuse between inmates and contractors or volunteers during this audit reporting period.</p>

For incidents of inmate-on-inmate sexual abuse, sexual harassment or retaliation, administrative sanctions will be handed out following the formal disciplinary processes and applied commensurate with the level of infraction. The Stutsman County Correctional Center prohibits all sexual activity among offenders and does not deem such activity to be sexual abuse if the activity is consensual. However, consensual activity is thoroughly investigated to ensure that it is truly consensual and not coerced.</p>

Any inmate that has experienced prior sexual victimization or has previously perpetrated sexual abuse, whether it occurred in an institutional setting or in the community, will be offered a follow-up meeting with a medical or mental health practitioner within 14 days of the intake screening. Interviews confirmed agency policy expectations and staff were aware of their responsibilities including limiting information strictly to medical and other staff, as necessary. Medical staff are aware of mandatory reporting laws for inmates.</p>

	<p>The auditor reviewed the Stutsman County Correctional Center PREA policy, documentation and interviewed staff and the nurse. PREA requirements are met for access to emergency medical and mental health services. In the event services after hours are not available by the facility medical staff, inmates are taken to the Jamestown Regional Medical Center in Jamestown.</p>
