

Official Proceedings of the Stutsman County Commission—January 16, 2024

At 3:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Jerry Bergquist, Chad Wolsky, Mark Klose, Levi Taylor, and Joan Morris (via telephone) answered the roll call.

The Pledge of Allegiance was recited.

Alyssa Looyesen, JSDC, presented a brief overview of Flex Pace funding usage for 2023 and requested 2024 Flex Pace funding, in the amount of \$100,000. A motion to approve was made by Bergquist, seconded by Wolsky. Roll call vote: Bergquist, Wolsky, Morris, Taylor, and Klose voted aye. Motion carried.

Maureen McGilvrey presented the designation of depositories and requested approval. The included banks are Dakota Heritage Bank, Bank Forward, Bell Bank, Unison Bank, First Community Credit Union, Hometown Credit Union, and Gate City Bank. A motion to approve was made by Morris, seconded by Taylor. Roll call vote: Wolsky, Morris, Taylor, Klose, and Bergquist voted aye.

Jim Wentland, Road Superintendent, requested approval to bid chip sealing for 18.2 miles of country road 67 south of Cleveland going to Gackle, including the county road within the city. A motion to approve was made by Wolsky, seconded by Bergquist. Unanimous aye vote. Motion carried.

Wentland also requested approval to bid a motor grader for the Kensal shop. The current one has 6,900 hours on it. The purchase is in his budget for 2024. A motion to approve was made by Bergquist, seconded by Wolsky. Unanimous aye vote. Motion carried. Wentland will also get numbers for the option of leasing.

Wentland provided an update on the Buchanan shop. Twenty additional feet would be needed to build the shop. Wentland spoke with the seller of the land, and he is willing to sell an additional 20 feet for \$1,000, bringing the total purchase price to \$9,500. Before the purchase of the land takes place, Wentland will make sure all zoning requirements are met. A motion to approve the purchase was made by Morris, seconded by Wolsky. Roll call vote: Morris, Taylor, Klose, Bergquist, and Wolsky voted aye.

An asset forfeiture application to pay Stutsman County Special Prosecutor Kara Brinster in the amount of \$358 was presented. A motion to approve the application was made by Bergquist, seconded by Taylor. Roll call vote: Taylor, Klose, Bergquist, Wolsky, and Morris voted aye. Motion carried.

Jessica Alonge, Auditor/COO, requested an extension of the joint library MOU. This would be the 3rd amendment to the MOU, to extend the agreement for one more year, giving the City of Jamestown the option to discuss the extension at their next committee meeting. A motion to approve the extension was made by Morris, seconded by Bergquist. Roll call vote: Klose, Bergquist, Wolsky, Morris, and Taylor voted aye. Motion carried.

Alonge presented century code on the term of office for the Library Board of Directors. Her request is to extend the current board appointments to June 30 of the year they are to expire, in order to comply with N.D.C.C. Currently the appointments go through the end of February. A motion to approve was made by Bergquist, seconded by Morris. Roll call vote: Bergquist, Wolsky, Morris, Taylor, and Klose voted aye. Motion carried.

A discussion was held on the Medina polling location. The Medina City Council has purchased and installed the handicap accessibility ramp at the Medina American Legion which was the polling location in 2022.

The cost per vote was \$13.59 in 2022, which included the rental of the ramp. The estimated cost per vote without ramp rental would be approximately \$6.11 for 2024. A motion to designate Medina as a polling location for the full election cycle of 2024 for precinct 472910 the was made by Wolsky, seconded by Taylor. Roll call vote: Wolsky, Morris, Taylor, Klose, and Bergquist, voted aye. Motion carried.

A motion to approve the beer license for Green Flag Promotions (Jamestown Speedway) was made by Bergquist, seconded by Taylor. Unanimous aye vote. Motion carried.

At 4:00 p.m., the Commission meeting recessed for the Park Board meeting.

Official Proceedings of the Stutsman County Park Board – January 16, 2024

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Park Board to order. Jerry Bergquist, Mark Klose, Chad Wolsky, Levi Taylor, Joan Morris (via telephone), and Merri Mooridian, answered the roll call. Henry Steinberger was absent.

At 4:02 p.m. Henry Steinberger joined the meeting via telephone.

Taylor made a motion to initiate 2024 dock permits on the Jamestown Reservoir, and to create a policies and procedures committee consisting of 7 members to include Alonge, Chad Kaiser, Sheriff, Karl Bergh, Park Superintendent, Levi Taylor, Steinberger, Mooridian, and Stutsman County resident Nic Spenningsby, to rework the current dock permit, seconded by Bergquist. Fritz Fremgen, State’s Attorney, has not yet finished his opinion on the land use agreement. Roll call vote: Morris, Taylor, Mooridian, Steinberger, Bergquist, and Wolsky voted aye. Klose voted no. Motion carried.

Alonge presented photos of vandalism at the vault toilet in the park shared use area. Bergh would like to see the toilet removed, it is original to 1979, the tank is cracked, and it leaks. The demolition of the structure and removal of the tank could be done between the park and road departments. Farmers Union would be willing to contribute up to \$3,000 to the purchase and installation of a new structure. A motion to allow for removal of the vault toilet was made by Steinberger, seconded by Mooridian. Unanimous aye vote. Motion carried.

Steinberger informed the board that there is an NDSU Extension Agent out of Dickinson, who works with the reintroduction of native plants and flowers that he has reached out to, to possibly get some funding for reintroduction of native plants and flowers and noxious weed control at the reservoir.

A motion to approve the mid-month park bills was made by Mooridian, seconded by Taylor. Roll call vote: Taylor, Klose, Mooridian, Bergquist, Wolsky, and Morris voted aye. Steinberger was absent or inaudible during the vote. Motion carried.
