

Official Proceeding of the Stutsman County Commission – February 5, 2019

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. David Schwartz, Steven Cichos, and Mark Klose answered the roll call. Dennis Ova and Ramone Gumke were absent.

Cichos made a motion, seconded by Schwartz, to approve the January 2019 meeting minutes. Motion carried.

Chairman Klose presented 2018 Stutsman County Service Awards.

Fritz Fremgen, State's Attorney, presented his monthly report.

Mickey Nenow, Road Superintendent, presented his monthly report. Winter maintenance is being done, as well as plowing snow.

Commissioner Cichos inquired how holiday and overtime pay works for road department employees.

A request to advertise for 2019 chip sealing was made by Nenow. We would be completing approximately 19.5 miles of chip seal. This expense has been built into the budget. Schwartz made a motion to approve the request, seconded by Cichos. Motion carried.

Nenow requested to purchase a service truck and pickup. The service truck and pickup purchase were budgeted for this year. Nenow is looking at a 2015 Dodge service truck out of Dickinson, ND for \$27,500.00. The pickup would be from the Sheriff's Office for \$18,000.00. Authorization was made, pending Nenow's approval of the service truck, by Schwartz, seconded by Cichos. Roll call vote: Schwartz, Cichos and Klose voted aye. Motion carried.

A request to advertise for gravel crushing was made by Nenow. It has been difficult for contractors to quote out pits. In previous years, the County had advertised with the pits to be determined. Nenow mentioned having a change in the process and having the bidders know the locations of the pits before placing a bid. There is no guarantee of gravel in the pits the County is finding. The pits are becoming depleted and running out of gravel. Chairman Klose would like the road department to review some of the pits to give bidders an idea of how to quote. Discussion tabled until future meeting.

Jim Fettig, Courthouse Maintenance Supervisor, presented the electrical bids. Fettig requested acceptance of all three bids from Jamestown Electric, Curtis Electric and Scott's Electric. Cichos made a motion to accept all three bids, seconded by Schwartz. Roll call vote: Cichos, Klose and Schwartz voted aye. Motion carried.

Fettig presented the plumbing bids from Arctic Zone Refrigeration and Joe Mechanical. A motion to accept both bids as presented was made by Schwartz, seconded by Cichos. Roll call vote: Klose, Schwartz and Cichos voted aye. Motion carried.

The Trane contract has gone up 6%. The total contract bid is \$5,135.00. Schwartz made a motion, seconded by Cichos, to accept the bid from Trane. Roll call vote: Schwartz, Cichos and Klose voted aye. Motion carried.

Corry Shevlin, JSDC, presented a change in policy and a request for 2019 FlexPACE program funding. Cichos made a motion to approve the change and accept the request, seconded by Schwartz. Roll call vote: Cichos, Klose and Schwartz voted aye. Motion carried.

Shevlin requested reimbursement for the 2018 Real Estate tax special assessments. This reimbursement would be for the Spiritwood property. Schwartz made a motion, seconded by Cichos, to approve the reimbursement. Roll call vote: Klose, Schwartz and Cichos voted aye. Motion carried.

A requested reimbursement for the 2018 CED loss was made by Shevlin. The chamber pays 18% of the lease with JSDC. Schwartz made a motion to approve the request, seconded by Cichos. Roll call vote: Cichos. Schwartz, Cichos and Klose voted aye. Motion carried.

Nicole Meland, Auditor/COO, presented a 2018 agency request review completed by Jamestown Tourism for the Frontier Village, Stutsman County Museum and the Arts Center. The funding they request from the County annually is in line with the expenditures they request it for. A motion to pay the 2019 agency request was made by Cichos, seconded by Schwartz. Roll call vote: Cichos, Klose and Schwartz voted aye. Motion carried.

A James River Valley Library Board appointment was presented by Meland. Lynn Krueger was the only applicant. Krueger is currently on the board. Schwartz made a motion to re-appoint Lynn Krueger, seconded by Schwartz.

Joe Rector, Director of James River Valley Library System, contacted Meland regarding the County designee for the Library. Previous commissioner Dale Marks was the County designee and is still attending the library board meetings and voting. Commissioner Ramone Gumke was the commission's appointee to take over that position. Marks would have to apply for an open position.

Meland requested approval of sale for parcel number 72-1100300. Schwartz made a motion to approve the request, seconded by Cichos. Motion carried.

The 2018 year-end transfers were presented by Meland. A motion to approve the transfers was made by Schwartz, seconded by Cichos. Motion carried.

Meland presented the 2018 budget adjustments. Cichos made a motion, seconded by Schwartz, to approve the adjustments. Motion carried.

Karl Bergh, Park Superintendent, presented his monthly report. Bergh is currently assisting Alonge and Meland with preparing the Lakeside Campground website.

Bergh requested permission to advertise for campground hosts at Lakeside and Parkhurst. Advertising would be done locally at first. Bergh feels a presence would stabilize some things out there. The position would be unpaid but would include a host spot. Hosts would be present Friday afternoon through Sunday afternoon. Schwartz made a motion to approve the request to advertise at both locations, seconded by Houge. Motion carried.

A request to advertise for sanitation bids was made by Bergh. This contract would be annual. Schwartz made a motion, seconded by Morris, to approve the request. Motion carried.

Permission to advertise for hay land rental and/or lease was made by Bergh. Cichos made a motion, seconded by Houge, to approve the request once acreage information is obtained. Motion carried.

Cichos was contacted by Mike Kesler, previous owner of Lakeside Marina, and mentioned the locks were changed on the marina building. Kesler should contact Bergh if he needs access to the building.

A lease review for the Jamestown reservoir building was discussed. The Campground Committee met to discuss fees. Fees were presented by Meland. Houge made a motion to approve the lease, contingent on the electric fee being negotiable, seconded by Schwartz. Motion carried.

Meland requested permission to advertise for the Jamestown Reservoir Marina building lease. Schwartz made a motion to approve the request, seconded by Houge. Motion carried.

Cichos made a motion to approve the presented cabin site permit renewals, seconded by Schwartz. Motion carried.

Dean Alber spoke on behalf of The D.A.K. at Pelican Point regarding concessionaire payments to the County and provided the board a ten-page report of concerns.

At 5:43 p.m., a motion to adjourn the meeting was made by Houge, seconded by Schwartz. Motion carried.

At 5:43 p.m., the Commission meeting was called back to order.
