

Official Proceedings of the Stutsman County Commission – February 4th, 2012

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call. Denny Ova was absent.

Marks made a motion, seconded by Neys to approve the minutes of the January 2012 meetings. Motion Carried.

Dustin Bakken, Staff Appraiser, informed the board of notification that was sent to Stutsman County regarding certified values from NDSU Department of Agribusiness showing a 31% increase with a 5.86% cap rate that was set on agricultural land values. The increase is determined by three items: the production data, the cost of production, and the cap rate which has always been set by the legislature. On non-crop land there is a 21% increase. Schwartz made a motion, seconded by Neys to oppose the cap rate increase and to request the Association of Counties to oppose this as well as having them request the legislature to address this in the next legislative session. Motion Carried.

Jerry Bergquist, 911 Coordinator/Emergency Manager, informed the board that he received the North Dakota Emergency Manager of the Year achievement award at the annual North Dakota Emergency Managers Association meeting.

Jerry Bergquist, 911 Coordinator/Emergency Manager, requested approval of out-of-state travel for Todd Volk to attend a FEMA Conference in Denver, Colorado. Neys made a motion, seconded by Schwartz to approve the travel request. Motion Carried.

Jerry Bergquist, 911 Coordinator/Emergency Manager, requested approval of an out-of-state travel for Todd Volk and Jerry Bergquist to attend an APCO International Conference in Minneapolis, Minnesota. Marks made a motion, seconded by Neys to approve the travel request. Motion Carried.

Howard Peuser, Maintenance Supervisor, requested approval to submit a grant for the Municipal Court Ramp and Door Project. The grant is an 80/20 split with Stutsman County's portion being \$1,665.00 for a grand total of the project being \$10,017.00. Schwartz made a motion, seconded by Neys to approve submitting the grant for the Municipal Court Ramp and Door project. Motion Carried.

Jim Fettig, Courthouse Maintenance Supervisor, requested approval to submit the second grant for the Stutsman County Elevator Modification Project. The grant is an 80/20 split with Stutsman County's portion being \$9,978.60 for a grand total of \$54,791.60. Marks made a motion, seconded by Schwartz to approve submitting the grant for the Elevator Modification Project. Motion Carried.

Jim Fettig, Courthouse Maintenance Supervisor, requested approval to submit the third grant for the Stutsman County Lower Level Restroom Remodel Project. The grant is an 80/20 split with

Stutsman County's portion being \$9,340.00 for a grand total of \$51,643.00. Marks made a motion, seconded by Schwartz to approve submitting the grant for the Lower Level Restroom Remodel Project. Motion Carried.

Steve Thompson, Interstate Engineering, presented preliminary engineering proposals for FEMA PW grants in Weld Township Site 4 for \$8,000.00; Weld Township Site 4A for \$8,000.00; St. Paul Township Site 1 for \$20,000.00; Sinclair Township Site 1 for \$20,000.00; Iosco Township Site 3 for \$12,000.00. Schwartz made a motion, seconded by Marks to approve Casey Bradley, Auditor/COO, signing the preliminary engineering FEMA proposals with Stutsman County paying for it and being 100% reimbursed by FEMA with the exception of St. Paul Township Site 1 which is being shared with the township. Roll Call Vote: Marks, Schwartz, Neys, Klose voted aye.

Steve Thompson, Interstate Engineering, presented information on the Department of Transportation construction maintenance agreements, the utility certification, and the right of way certification for the three ER projects that are coming up on a March bid opening. It is for the paving for all three projects: a realignment south of Cleveland, the 2010 Vandenberg grade raise and the 2010 grade raise that is south of Cleveland that is above water. Neys made a motion, seconded by Schwartz to authorize signatures on the construction maintenance agreements. Motion Carried.

Mickey Nenow, Interim County Highway Superintendent, informed the board that they received a letter from North Dakota Department of Transportation (DOT) that they will be conducting traffic counts in regions two and three this summer which is western and central North Dakota. They will do up to twelve roads free of charge. The traffic counters will be on the roads in a couple of spots where we are anticipating projects and will be in place for approximately one week. Also, Mickey is continuing to work with the FEMA projects that are still open.

Schwartz made a motion, seconded by Marks to appoint Mickey Nenow from Interim County Highway Superintendent to County Highway Superintendent permanently. Roll call vote: Schwartz, Neys, Klose, Marks voted aye.

Casey Bradley, Auditor/COO, and Schwartz presented information on the road right of way infringements which could jeopardize our funding if we do not enforce them. In the past, the County has attempted, but failed to enforce them. Schwartz has been traveling every county road and marking every area where road right of way is infringed upon. A letter of notification will be sent to the landowners who are in violation. If they do not correct it, the County will have to enforce it and do an assessment through taxes to the landowner who is in violation. Schwartz is in the process of assessing all county roads and will present a list of landowners who are in apparent violation of right of way infringements. We are mandated by law to enforce the road right of ways within the county. Schwartz would like to publish a notice in the paper regarding enforcement of road right of ways as soon as possible. Schwartz made a motion, seconded by Marks to publish road right of ways intent in the Jamestown Sun. Motion Carried.

Casey Bradley, Auditor/COO, presented information on the Jail Food Service Request for Proposals. Each vendor submitted a cost summary based on a per meal cost method that ranged from 50-104 meals with pricing changes at five meal increments. For comparative

purposes, 61 meals were used as an average daily population to estimate total cost for our facility. Stutsman County received three proposals from Aramark at \$2.629 per meal, CBM at \$2.385 per meal, and A'Viands at \$2.223 per meal with a projected 2012 cost savings to the County of \$125,533 from Aramark, \$141,898 from CBM and \$152,719 from A'Viands. After the announcement of the monetary portion, the committee, which consisted of Jail Administrator Trapp, Sheriff's Deputy Gumke, Sheriff Kaiser and Auditor/COO Bradley, viewed the specifications for each proposal and found each proposal was in compliance and complete. The committee identified several items that they felt needed to be taken into consideration: staffing plan, the offer of employment to existing staff at their current rate of pay, and the meal plan including the excessive use of substitutions. The committee felt that CBM's proposal more closely matched that of our existing meal plan, utilized only minimal substitutions, and also has a provision to hire all existing food service staff at their current hourly wage plus benefits; therefore it is a recommendation of the committee to accept CBM's proposal. Schwartz made a motion, seconded by Neys to accept the recommendation of the Jail Food Service committee to accept CBM's proposal. Roll call vote: Neys, Klose, Marks, Schwartz voted aye.

Bradley, Auditor/COO requested permission to advertise and fill the vacancy for the Audit Support Assistant position. Neys made a motion, seconded by Schwartz to authorize Bradley to fill the vacancy in the Audit Support Assistant position. Motion Carried.

Casey Bradley, Auditor/COO, informed the commissioners that Toni Hible, Tax Equalization Director, was terminated effective February 7th, 2012. We are required by statute to have a Tax Equalization Director or someone with the duties of a Tax Director. By November, we are anticipating Dustin will be one class away from receiving his certification. Bradley requested that Dustin Bakken be appointed as Interim Tax Equalization Director and contract with Noel Johnson on an hourly basis to assist Dustin Bakken. Schwartz made a motion, seconded by Neys to approve contract for services with Noel Johnson. Roll call vote: Klose, Marks, Schwartz, Neys voted aye.

Schwartz made a motion, seconded by Neys to approve appointing Dustin Bakken as Interim Tax Equalization Director. Roll call vote: Marks, Schwartz, Neys, Klose voted aye.

A motion was made by Marks and seconded by Neys to pay the bills as presented. Roll call vote: Schwartz, Neys, Klose, Marks voted aye.
