

Official Proceedings of the Stutsman County Commission – February 21st, 2012

At 8:00 a.m., Chairman Ova called the regular meeting of the Stutsman County Commission to order. Dale Marks, David Schwartz, Craig Neys, and Denny Ova answered the roll call. Mark T. Klose was absent.

Casey Bradley, Auditor/COO presented the 2011 End of Year Expenditures and Revenues for all of the County Funds. The report was broke out by departments and focuses on a cash basis with no accruals added in. All of the funds did pretty well except for the Emergency Fund and the Correctional Center Fund.

Casey Bradley, Auditor/COO presented the CBM Managed Services Contract for signatures. The CBM Managed Services Contract has a stipulation in the contract to offer/hire the existing staff at the same hourly wage in accordance to the 2012 wage grid system and benefits comparable to existing county benefits. CBM also has no contract period end date with a 90 day out clause with the contract hopefully taking effect March 1<sup>st</sup>, 2012. Ashley Heitkamp, Assistant States Attorney, has reviewed the contract. Neys made a motion, seconded by Schwartz to accept the CBM Managed Services Contract. Roll call vote: Ova, Marks, Schwartz, Neys voted aye.

Jeff Mitchell requested to close three section lines. The township believes that they do not have the authority to close the section lines. The statute gives the County the authority to close the section lines. The statute states if a petition by the person having interest in adjoining land or a portion thereof, after a public hearing and a finding by the Commissioners of public benefit, may close section lines or portions thereof which are not used for ten years, are not traveled due to natural obstacles or difficulty or terrain, are not required due to readily accessible alternate routes of travel, or are intersected by interstate highways causing the section line to be dead-end, providing the closing of the dead-end section line does not deprive adjacent landowners access to the landowners' property. The consensus of the Commissioners is that it is not within their authority to close the three section lines. Jeff does have an agreement with Nogosek Township to have cattle gates in place. It is the townships authority to grant the cattle gates and cattle guards. It was recommended that Jeff Mitchell get an opinion from the Attorney General.

Laurie McGuire, James River Senior Center, informed the Commissioners the James River Senior Center will be relocating to the old Jamestown Hospital building with a projected move in date of February 2013 depending upon the construction of the old hospital in the cafeteria and physical therapy area. The Senior Center is expanding because they are outgrowing their space. Classic Catering, which is for profit, needs to expand. This program helps balance out our other programs. James River Senior Center owns the land under the bus storage facility; therefore the bus storage facility and James River Fleet will remain on the current site.

Casey Bradley, Auditor/COO, requested the main floor restrooms be designated as employee only. Stutsman County previously submitted a CDBG grant for the ADA compliance for the Lower Level

Restrooms. The Grant Committee won't consider us for a grant unless we designate the Main Floor Restrooms as Employee Only. Schwartz made a motion, seconded by Neys to designate the main floor restrooms as employee only. Roll call vote: Marks, Schwartz, Neys, Ova voted aye.

Marks made a motion, seconded by Schwartz to approve the taxable meals and mid-month bills. Roll Call vote: Schwartz, Neys, Klose, Ova, Marks voted aye.
