

Official Proceedings of the Stutsman County Commission—April 18, 2023

At 3:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Jerry Bergquist, Chad Wolsky, Joan Morris, Steven Cichos (via phone) and Mark Klose answered the roll call.

A motion was made by Bergquist to approve the March 2023 meeting minutes, seconded by Wolsky. Motion carried.

Jim Fettig, Maintenance Supervisor, requested permission to attend the 2023 Dacotah Paper Co. Trade Show in Moorhead, MN on April 26. A motion to approve the travel was made by Morris, seconded by Cichos. Motion carried.

Christina Rittenbach, Extension Agent, requested permission to purchase a desk and hutch. A motion to approve the purchase was made by Cichos, seconded by Bergquist. Roll call vote: Bergquist, Wolsky, Morris, Cichos, and Klose voted aye. Motion carried.

Jim Wentland, Road Superintendent, requested permission to award the motor grader bid to John Deere including accessories, for \$340,800 after trade-in. A motion to approve the purchase was made by Wolsky, seconded by Bergquist. Roll call vote: Wolsky, Morris, Cichos, Klose, and Bergquist voted aye. Motion carried.

Andrew Kirking, Emergency Manager, proposed a flood declaration be made for Stutsman County. A motion to approve the declaration was made by Morris, seconded by Cichos. Roll call vote: Morris, Cichos, Klose, Bergquist, and Wolsky voted aye. Motion carried.

Shannon Davis, Human Resources Director, presented potential roof safety issues for maintenance employees who work on the rooftops of the courthouse, Memorial, Extension, and LEC buildings. She completed an inspection of each roof with Fettig and the ND Association of Counties Safety Director. NDACo provided a list of safety equipment. Davis requested permission to purchase up to \$20,000 in safety equipment, such as harnesses, guard rails, and I-beams. A motion to approve the purchase, not to exceed \$20,000, was made by Cichos, seconded by Wolsky. Roll call vote: Cichos, Klose, Bergquist, Wolsky, and Morris voted aye. Motion carried.

Jessica Alonge, Auditor/COO, presented National County Government Month activities. Alonge invited all Commissioners and Park Board members to attend the open house being held in the courthouse lobby April 21.

Alonge presented bids for the 5-year pasture lease for the N1/2SE1/4, Section 23, Township 141, Range 65, Hidden Twp. One bid from Ronald Holzworth, the current lessee, was received in the amount of \$660.00 per year. A motion to accept the bid was made by Cichos, seconded by Morris. Roll call vote: Klose, Bergquist, Wolsky, Morris, and Cichos voted aye. Motion carried.

At 4:02 P.M., the Commission recessed for the County Park Board meeting.

## Official Proceedings of the Stutsman County Park Board – April 18, 2023

At 4:03 p.m., Chairman Klose called the regular meeting of the Stutsman County Park Board to order. Jerry Bergquist, Chad Wolsky, Joan Morris, Steven Cichos (via phone), Mark Klose, and Robert Martin answered the roll call. Merri Mooridian was absent.

A motion was made by Bergquist to approve the March 2023 meeting minutes, seconded by Wolsky. Motion carried.

Keith Domke, Jamestown Marksmanship Club, is interested in developing 5 acres in Parkhurst Campground, currently managed by the Park Board, for an indoor gun range. Martin informed Domke that the Park board typically would require a 3<sup>rd</sup> party agreement for this lease with the Corp of Engineers. A motion to send a letter of support to the Corp of Engineers was made by Wolsky, seconded by Martin. Roll call vote: Martin, Bergquist, Wolsky, Morris, Cichos, and Klose voted aye. Motion carried.

Lucas Dockter, Hondo's Hideaway, presented project upgrades to the Marina building such as plumbing, pergola, shade awning, public dock, beach addition, and heating and cooling systems. Dockter has funds for the proposed projects. A motion to approve the upgrades was made by Morris, seconded by Cichos. Roll call vote: Bergquist, Wolsky, Morris, Cichos, Klose, and Martin voted aye. Motion carried.

Fritz Fremgen, State's Attorney, discussed the State's Attorney opinion request from the March 21 meeting regarding private dock permits at the Reservoir. Fremgen is short-staffed and unable to do the research. Fremgen spoke to several attorneys and was able to find two who are qualified and willing to conduct the research. Fremgen recommended Scott Porsburg of Smith Porsburg at \$230 per hour, or Charles Carvell at \$225 per hour. Carvell has experience with similar law. A motion to approve the hiring of Charles Carvell as a Special Assistant State's Attorney was made by Bergquist, seconded by Cichos. Roll call vote: Wolsky, Roll call vote: Morris, Cichos, Klose, Martin, and Bergquist voted aye. Motion carried.

Joan Enderle, Stutsman County resident, reminded the Board of the background and terms of the "grandfathered" dock permits. Martin made a motion to renew the 2 grandfathered dock permits for 2023 at the same rate, seconded by Wolsky. Roll call vote: Morris, Cichos, Klose, Martin, Bergquist, and Wolsky voted aye. Motion carried.

Bergquist made a motion to renew the private dock permits that were in place in 2022 for the 2023 season, while the research is being conducted, seconded by Martin. Commissioner Wolsky declared a conflict of interest due to having a 2022 dock permit. Roll call vote on declaration of the conflict: Morris, Cichos, Klose, Martin, and Bergquist voted aye. Roll call vote on the Motion: Cichos, Klose, Martin, Bergquist, and Morris voted aye. Motion carried.

Karl Bergh, Park Superintendent, requested permission to purchase new winter tires and rims for the skidsteer. The cost will be approximately \$1,800-\$2,200. A motion to approve the purchase was made by Cichos, seconded by Wolsky. Roll call vote: Klose, Martin, Bergquist, Wolsky, Morris, and Cichos voted aye. Motion carried.

Alonge presented leases for Klein and Laraway at Spiritwood Lake that are up for renewal in 2023. They are 5-year leases at a rate of \$25.00 per year. The Board last increased the rate from \$15.00 to \$25.00 in 2013. A motion was made by Cichos to renew the 5-year leases at \$40.00 per year, seconded by Morris. Roll call vote: Martin, Bergquist, Wolsky, Morris, Cichos, and Klose voted aye. Motion carried.

A motion to approve payment of the monthly and mid-month bills was made by Bergquist, seconded by Cichos. Roll call vote: Bergquist, Wolsky, Morris, Cichos, Klose, and Martin voted aye. Motion carried.
