

Official Proceedings of the Stutsman County Commission – April 19, 2022

At 3:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Joan Morris, Steve Cichos, and Mark Klose answered the roll call. Ramone Gumke was absent.

Robin Iszler, Central Valley Health District presented the 2021 Annual Report.

At 3:33 p.m., Ramone Gumke joined the meeting via phone.

Klose presented history of Arrowwood National Wildlife. According to Century Code the annual refuge revenue payments made to the county are apportioned among the school districts (25%) and townships (75%). Paul Halko, Arrowwood National Wildlife Refuge Manager, reminded everyone that the county would still get the county trust payment. Klose mentioned that trust payment cannot exceed 10% of appraised value. The land will be a waterfowl production area and will be open to the public. Chuck Bosch, Reality Specialist at U.S. Fish and Wildlife Services, reassured the land would not be taken out of a waterfowl production area. A motion was made by Cichos to allow Arrowwood to proceed with appraisal, seconded by Morris. Ova, Gumke, Morris, and Cichos voted aye. Klose voted no. Motion carried.

Jim Fettig, Maintenance Supervisor requested permission to purchase and install a new heat pump. The cost is \$5,260 for the heat pump. The installation of the heat pump would be \$1,200.00. Fettig also requested permission to replace some ceiling tiles costing roughly \$600.00, and to add a ceiling fan costing \$800.00. The total cost of the project is approximately \$8,000. A motion was made by Ova to approve, seconded by Cichos. Gumke, Morris, Cichos, Klose, and Ova voted aye. Motion Carried.

Fettig requested permission to travel to a Dacotah Paper seminar in Moorhead, MN. He will bring all his staff and one employee from the park department. A motion was made by Morris to approve, seconded by Ova. Motion carried.

Tyler Perleberg, Director of Tax Equalization and Zoning Administrator presented application for property tax exemption for improvements to a building; Parcel #16-0421020. The owners added an old church to their personal property and renovated it into a rec-center for themselves. Township board meetings would also be held in this building. The exemption amount is for \$75,000 and is allowed up to five years. A motion was made by Cichos to allow the exemption for three years. Seconded by Ova. Morris, Cichos, Klose, Ova, and Gumke voted aye. Motion carried.

Mickey Nenow asked for approval of RFP's. Nenow recommends using Interstate Engineering for all three projects. A motion was made by Cichos to approve, seconded by Morris. Cichos, Klose, Ova, Gumke, and Morris voted aye. Motion carried.

Nenow asked for the approval of the resolution for the grade raise. Guthmiller Earthmoving Inc was awarded the bid for \$1,768,154.31. A motion was made by Morris to approve, seconded by Cichos. Motion carried.

Andrew Kirking Emergency Manager/9-1-1 Coordinator requested permission to increase the dispatch department from ten and a half positions to eleven full time positions. A motion was made by Cichos to approve of advertisement, seconded by Morris. Motion carried.

Kirking mentioned that the 5-year mitigation was approved. Stutsman county is covered through 2027.

Chad Kaiser, Sheriff requested approval to advertise for bids for the building project. Kaiser presented four location proposals for the building. The bids would only be for the building cost itself. Morris asked about security concerns. Kaiser is not concerned about any security issues. A motion was made by Cichos to allow the bid and would like to delete option one location south of the Game and Fish, seconded by Gumke. Motion carried. Klose would like a list of equipment that will be stored in the building.

Jessica Alonge, Auditor/COO provided appointments for absentee poll workers. A motion was made by Ova to approve, seconded by Morris. Motion carried.

Official Proceedings of the Stutsman County Park Board – April 19, 2022

4:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Park Board to order. Mark Klose, Joan Morris, Dennis Ova, Steve Cichos, Ramone Gumke (via Phone), and Bob Martin answered the roll call. Merri Mooridian was absent.

Chad Kaiser, Sheriff, has made a request through the Bureau of Reclamation for road access to the first building site option south of Game and Fish. This grants use of right away across bureau lands back to Park Board property. A motion was made by Gumke to approve, seconded by Ova. Motion carried.

Jessica Alonge, Auditor/COO presented 2022 Dock Permits. A question was presented whether it is allowed to have a someone else's boat at a dock. The permit allows only boats registered to the dock owner.

Karl Bergh, Park Superintendent, stated that Scott's Electric mapped out all of the electrical and identified where the overuse is happening at Lakeside Campground. He also stated that Northern Plains did an assessment of the usage of energy at the campground. The transformer has never been maxed out. It is the distribution of the energy that is causing the issue. The proposal will take the power and distribute it more evenly. Scott's Electric estimate is \$7,480.00.

At 4:44 p.m. Ova left the meeting.

Bergh presented a proposal for paving the road in Lakeside Campground. The paving would not affect the camping season. The paving would go all the way to the road tying into the existing asphalt. One quote from December 1st, 2021, is from Boarder States costing \$99,250.00, and the other is from Interstate Engineering costing around \$139,231.00.

Bergh presented a proposal for purchasing a furnace in the shop. Mackke Plumbing and Heating gave a quote of \$3,350.00. Bergh has the furnace budgeted in 2023 but would take from that fund in 2022 and replenish it next year with the difference. A motion was made by Martin to approve, seconded by Morris. Klose, Martin, Gumke, Morris, and Cichos voted aye. Motion carried.

A motion was made by Morris to upgrade the electrical at Lakeside Campground using ARPA funding not to exceed 7,500.00, seconded by Cichos. Martin, Gumke, Morris, Cichos, and Klose voted aye. Motion carried.

A motion was made by Morris to approve of paving the campsite not exceeding \$99,999, with funds coming out of ARPA, Martin seconded. Morris would like an analysis for Stutsman County camping rates with other camping sites with an intent to increase camping rates in 2023.

Morris withdrew the motion regarding paving.

A motion was made by Morris to proceed with the paving of Lakeside Campground to be paid through the ARPA Fund not to exceed \$125,000, Martin seconded. Gumke, Morris, Cichos, Klose, Martin all voted aye. Motion carried.

At 5:07 p.m., Ramone Gumke left the meeting.

Bob Martin presented an update on the Jamestown Dam. He stated the Bureau has started the release. It is in a flood zone stage at 1.434.

A motion was made by Cichos to approve of the monthly bills. Seconded by Morris. Morris, Cichos, Klose, and Martin voted aye. Motion carried.
