Official Proceedings of the Stutsman County Commission - May 3rd, 2016

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Neys made a motion, seconded by Schwartz to approve the minutes of the April 2016 meetings. Motion carried.

Jerry Bergquist, 9-1-1 Emergency Manager/Coordinator, requested permission for the current President of the ND Chapter of APCO (Association of Public-Safety Communications Officials), Pam Blinsky, to attend the National APCO Conference in Orlando, Florida, August 14-17 with all travel expenses paid by APCO. A motion was made by Ova, seconded by Marks to allow out-of-state travel for Pam Blinsky. Motion carried.

Lynne Tally, Executive Director of Safe Shelter, requested approval of Stutsman County to act as a sponsoring agent. A new building that will house their offices and three apartment buildings is being drawn up. Three months is the estimated time frame for this project. There is a donor of \$500,000.00, who will not be publically named as of yet. Land is secured. Marks made a motion to approve the request, seconded by Ova. Motion carried.

Casey Bradley, Auditor/COO, requested approval of Sunday Beer Permit for Stutsman County Fair, Inc. as well as approval of Beer Permit and Sunday Beer Permit for Jamestown Speedway. Ova made a motion, seconded by Schwartz to approve beer permits for the above noted. Motion carried.

Adding a new fund for disbursement of camping funds for Pelican Point was requested by Casey Bradley. This new fund would be kept separate and be established as a pass-through fund. Some cash flow issues have risen within the Rec.gov. Stutsman County would receive 100% of camping fees and be disbursed back to concessionaires. This Special Revenue Fund would be zeroed out at the end of each year with the interest being paid to the concessionaires. Neys made a motion to approve the adding of a new special revenue fund, seconded by Schwartz. Motion carried.

Casey Bradley made a request for approval of poll workers. Schwartz made a motion to appoint the poll workers listed, seconded by Marks. Motion carried.

Tyler Perleberg, Tax Director, requested approval for a Conditional Use Permit application for Brandon and Lacy Koenig. The feedlot is located in the NE ¼ of Section 35, Wadsworth Township. Cattle will be expanded from 400 to 600. Per Stutsman Counties zoning ordinance, they need to get approved for a Conditional Use Permit. The Planning and Zoning Committee approved this on April 14, 2016, unanimously. Even with the approval of the Commissioners, this is still pending in the State Health Department's approval before their final permit being granted. A motion was made by Neys, seconded by Ova to approve the Conditional Use Permit. Roll call vote: Ova, Marks, Schwartz, Neys and Klose. Motion carried.

Chad Kaiser, Sheriff, gave his monthly report. 2015 Statistics will be presented at an upcoming Commission Meeting. There is an open Sheriff Deputy position available. A request was made for out-of-state travel for Dreamos, Sheriff Kaiser and Chief Edinger for training in Texas. Ova made a motion to approve the out-of-state travel, seconded by Marks. Motion carried.

Donna and Robert Lindberg voiced their concerns with the shooting range. The commissioners tabled the subject until the June Commission Meeting.

Fritz Fremgen, States Attorney, presented his monthly report.

Mickey Nenow, Road Superintendent, presented his monthly report and updates on upcoming road projects. The Road Department is looking at building a new shop in Medina. The requested proposal would be an exchange of the existing shop and lot for the lot owned by Gene Guthmiller. Marks made a motion to approve the exchange, seconded by Schwartz. Roll call vote: Marks, Schwartz, Neys, Klose and Ova. Motion carried.

At 4:48 p.m., the Stutsman County Commission Meeting recessed for the County Park Board Meeting.

McKays' taxes are current, not delinquent, but the second half of McKays' taxes are still owed. A motion was made by Houge not to levy any fines against McKay and to dismiss alleged violations with the agreement to send future correspondence stating that the next year's payment will need to be paid in full by April 15th and comply with the permit, seconded

by Schwartz. Motion carried. A motion was made by Neys, seconded by Marks to disregard the alleged violations for failure to pay taxes, not pursue any penalties and send a letter of reprimand. Roll call vote, Neys – yes, Klose – no, Houge – no, Woodward – no, Ova – no, Marks – yes and Schwartz – no. Motion failed. Marks made a motion to acknowledge the determination of violations of leases and permits, seconded by Schwartz. Motion carried.

Dennis Lorenz, County Park Superintendent, presented his monthly report. He stated his concerns regarding the road on the West side of Pelican Point. Redirecting the water flow was in discussion. Park updates were given. Water samples all came back good.

Neys made a motion to pay Jim Schumacher \$100.00 for his labor performed at the campground, seconded by Ova. Roll call vote: Klose, Houge, Woodward, Ova, Marks, Schwartz and Neys. Motion carried.

At 5:55 p.m., a motion to adjourn the Stutsman County Park Board meeting was made by Houge, seconded by Schwartz. Motion carried.

Marks made a motion, seconded by Ova to approve monthly bills. Roll call vote: Ova, Marks, Schwartz, Neys and Klose. Motion carried.
