Official Proceedings of the Stutsman County Commission – May 15th, 2012

At 8:00 a.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Denny Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Steve Thompson, Interstate Engineering, presented information for approval of Project Concept Report (PCR) and executive decisions for the Larson grade raise, project number CER-4742(061). The options to choose from are —to build or not to build. If choose not to build, Stutsman County would have to pay back the federal aid dollars they received last year due to not satisfying the environmental commitment. If choose build, then two options to choose from. One is to do a two foot grade raise which essentially we have now but Stutsman County would need to widen the existing project to meet current federal aid standards. This option would cost approximately \$691,500.00 which is an 80/20 split. The other option is to do a realignment which would cost approximately \$725,000.00. If Stutsman County chooses this option it may have to relocate one farmstead. Schwartz made a motion, seconded by Marks to approve the two foot grade raise for project number CER-4742(061), the Larson grade raise as presented. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

Steve presented information for approval of PCR and executive decisions for CER-4711(052) which is known as the Enzminger grade raise. The options to choose from are – to build or not to build. If choose build, then two options to choose from: to do a two foot grade raise which would cost approximately \$915,000.00 or to do a realignment which would cost approximately \$938,000.00. If choose the realignment option, a portion of the land is enrolled in the CRP program, has US Fish and Wildlife Management easements, and potential cultural resource sites. This could delay the project due to the several environmental concerns that would need to be investigated. Schwartz made a motion, seconded by Marks to approve the two foot grade raise on project number CER-4711(052), the Enzminger grade raise. Roll call vote: Marks, Schwartz, Neys, Klose, Ova voted aye.

Steve presented the review and approval of construction engineering agreements for the following paving projects: CER-4717(082), five miles south of Cleveland which is \$11,591.27; CER-4717(083), two miles south of Cleveland which is \$12,138.68; and CER-4717(084), realignment one mile south of Cleveland which is \$31,393.41. These paving projects are all an 80/20 split and the contract is with the Department of Transportation. Schwartz made a motion, seconded by Marks to approve the construction engineering agreements for CER-4717(082), CER-4717(083), and CER-4717(084) paving projects as presented. Roll call vote: Schwartz, Neys, Klose, Ova, Marks voted aye.

Bids were opened for the Stink Lake grade raise. Bids were as follows: Lindberg Brothers Inc. -- \$599,737.54; Guthmiller Earthmoving, Inc. -- \$570,319.00; and RTS Shearing, LLC -- \$480,821.00. Steve Thompson, Interstate Engineering reviewed the bids.

Jim Fettig, Courthouse Maintenance Supervisor, requested approval for out-of-state travel for Howard Peuser and himself to attend a Steins Chemical Company Equipment Seminar in Moorhead, Minnesota. Neys made a motion, seconded by Schwartz to approve the travel request. Motion Carried.

Ova made a motion, seconded by Neys to approve the three gaming site authorizations for the North Dakota Buffalo Foundation Inc. at Anchor Bar, 281 Stop, and the Buchanan Bar. Motion Carried.

Casey Bradley, Auditor/COO presented the appointments of the party canvas board members and county canvas members for June 15<sup>th</sup>, 2012 at 9:00 a.m. They are as follows: District 12 Republican -- Delores Rath, District 12 Democrat -- Dean Remboldt, District 29 Republican -- Tom Christensen, District 29 Democrat -- Ann Marks, County Auditor -- Casey Bradley, County Recorder Representative -- Cheryl McPherson, and Commission Representative -- Dennis Ova. Neys made a motion, seconded by Schwartz to approve the appointments of the party canvas board members and Stutsman County canvas members as presented. Motion Carried.

Jason Bitz, Insure Forward, presented information for the 2012-2013 insurance policy renewals. The Business Auto is \$42,213.00; General Liability is \$40,722.00; Inland Marine is \$13,733.00 for a total of \$96,668.00 with a conferment of \$18,892.00 for a grand total cost of \$77,776.00 for the 2012-2013 year. Ova made a motion, seconded by Schwartz to approve the renewal of the insurance for 2012-2013 as presented. Roll call vote: Neys, Klose, Ova, Marks, Schwartz voted aye.

Neys made a motion, seconded by Schwartz to approve a local raffle permit for Buffalo City Gun Club. Motion Carried.

Casey Bradley, Auditor/COO, provided information to the commission board on the LaRoush Pack. The LaRoush Pack is notifying every County Auditor in the State of North Dakota. The LaRoush Pack is requesting to be put on the agenda. If the commission board is interested and would like to have the information on the agenda, they would need to inform Casey.

Schwartz made a motion, seconded by Marks to approve the taxable meals and the mid-month bills for payment. Roll call vote: Klose, Ova, Marks, Schwartz, Neys voted aye.
