

Official Proceedings of the Stutsman County Commission – May 19, 2020

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova (via phone), Ramone Gumke (via phone), David Schwartz, Steven Cichos (via phone), and Mark Klose answered the roll call.

Jason Bitz, Insure Forward, presented the renewal of general liability, in-land marine, and auto coverage insurance information. The 2020 policy renewal will be \$120,993 compared to \$142,043 in 2019. It decreased because of the conferment payment received totaling \$25,315. Ova made a motion to renew the coverage with Insure Forward, seconded by Gumke. Ova, Gumke, Schwartz, Cichos, and Klose voted aye. Motion carried.

Corry Shevlin, JSDC, discussed engineering costs to complete preliminary design reports and surveys for a potential greenhouse facility at Spiritwood Energy Park. The cost of the study would be recouped when a tenant utilizes the site. The County share would be \$4,200. Cichos made a motion to approve, seconded by Schwartz. Gumke, Schwartz, Cichos, Klose, and Ova voted aye. Motion carried.

Commissioner Schwartz discussed the need for additional height on the grade raise on County Road 37 in Streeter Township. An extra foot will cost approximately \$25,000-\$30,000. Guthmiller can complete the additional work quickly since they are already there. Schwartz made a motion to approve Guthmiller doing an additional grade raise, seconded by Gumke. Schwartz, Cichos, Klose, Ova, and Gumke voted aye.

Schwartz discussed advertising for quotes for two additional grade raises on County Road 67. We didn't previously advertise the grade raises because we were waiting for the water to go down after the drain installation. The funding will come from the Emergency Fund. Schwartz made a motion to advertise for quotes and draw up specs for the two sites, seconded by Cichos. Motion carried.

Nicole Meland, Auditor/COO discussed a request for use of Task Force asset forfeiture funds. Due to legislative changes, asset forfeitures are required to have a separate fund and requests must be filed and approved by the commission to use them. Tonya Duffy has been handling the proceedings of asset forfeiture cases and the agreement was to pay her 20% of the forfeiture amount. The payment totals \$363.00. Schwartz made a motion to approve the payment, seconded by Gumke. Cichos, Klose, Gumke, and Schwartz voted aye. Motion carried.

Meland discussed an update to the COVID-19 employee policy. The governor loosened travel restrictions for the state. Department heads met and agreed to follow the governor's orders and lift out-of-state travel restrictions for employees. International travel still requires a 14-day self-quarantine. Schwartz made a motion to approve the policy update, seconded by Gumke. Motion carried.

Meland gave an update on CARES funding. The State Emergency Commission is now saying they will look at County requests for funding at their June meeting. Counties should report costs from March 1-May 31 and estimate costs for June-September.

Meland gave an update on the Fall 2019 FEMA disaster. Senators Cramer and Hoeven, and Representative Headland held a meeting last week, and Meland will be holding meetings with the townships this week. They will go over approvals from FEMA from the fall, damages, and costs.

Meland discussed requests for personal protective equipment for reopening of Stutsman County Offices. The State's Attorney's office and first floor offices requested "sneeze guards". Newman Signs is selling 24 x 36-inch plastic shields for \$75 each. Gloves, masks, and hand sanitizer stations may be needed as well. The costs could be submitted for CARES funding. Schwartz made a motion to approve the purchases as necessary, seconded by Ova. Klose, Ova, Gumke, Schwartz, and Cichos voted aye. Motion carried.

Schwartz made a motion, seconded by Cichos, to approve the presented taxable meals and mid-month bills. Ova, Gumke, Schwartz, Cichos, and Klose voted aye. Motion carried.
