

Official Proceedings of the Stutsman County Commission – June 5, 2018

At 4:00 p.m., Chairman Mark Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, and Mark Klose answered the roll call.

Ova made a motion, seconded by Marks to approve the May 2018 Minutes. Motion carried.

Nicole Meland, Auditor/COO requested approval of the Canvass Board members for the June 12, 2018 Primary Election. A Commissioner also needs to be on the Board. David Schwartz volunteered to serve as the Commission representative. Neys made a motion to approve the Canvass Board, seconded by Ova. Motion carried.

Meland presented the final poll worker list for the 2018 Primary Election. All positions have now been filled. Schwartz made a motion, seconded by Marks to approve the poll worker list. Motion carried.

Meland requested a request for nomination and appointment of board members to the City of Jamestown Planning Commission, the Central Valley Health District Board, and the Housing Authority Board for the term of July 1, 2018 to June 30, 2023. Corey Bayer was the only applicant and is currently on the board for the City of Jamestown Planning Commission. Dr. James Torrance applied for the Central Valley Health District Board, is currently on the board, and was the only applicant. David Bratton was the only applicant for the Housing Authority Board. Ova made a motion, seconded by Marks to approve the appointments. Roll call vote: Klose, Ova, Marks, Schwartz, and Neys voted aye. Motion carried.

Daren Peterka from Interstate Engineering presented an application for the BUILD Transportation Discretionary Grant Program. This is a federal grant program that focuses on rural transportation issues. They have had two other successful applications in the past. They prefer applications for projects that would be fast-acting and have approval and support in place. Since this application is tied to tourism and access to federal lands it could also receive extra points. Ova made a motion to move forward with the grant application, seconded by Marks. Ova, Marks, Schwartz, Neys, and Klose voted aye. Motion carried.

Chad Kaiser, Stutsman County Sheriff, presented a request to contract with Leo Ryan for forfeiture services. These cases are time-sensitive and can result in revenue for the County. Fritz Fremgen, State's Attorney, has approved working with Leo Ryan for these services. Schwartz made a motion to approve the contract, seconded by Neys. Marks, Schwartz, Neys, Klose, and Ova voted aye. Motion carried.

Fritz Fremgen, State's Attorney, presented his monthly report. Fremgen is requesting approval to hire additional staff of one support staff and one attorney. Fremgen would like to reduce the amount of overtime put in by himself and the Assistant State's Attorneys.

Mickey Nenow, County Highway Superintendent, presented his monthly report. Crack sealing and patching is continuing. Road restrictions on the gravel roads will continue for another week or so. The County 39 project will possibly start in July.

Nenow requested to advertise for a Motor Grader at the Woodworth Shop that was budgeted for in 2018. Ova made a motion to approve, seconded by Schwartz. Motion carried.

Nenow also requested approval of Construction Engineering for the County 39 project. Marks made a motion, seconded by Ova to award Construction Engineering to Interstate. Schwartz, Neys, Klose, Ova, and Marks voted aye. Motion carried.

At 4:45 p.m., The Stutsman County Commission Meeting recessed for the County Park Board Meeting.

At 4:50 p.m., Chairman Mark Klose called the regular meeting of the Stutsman County Park Board to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, Mark Klose, Robert Woodward, and Jason Houge answered the roll call.

Ova made a motion, seconded by Houge to approve the minutes of the May 2018 meeting. Motion carried.

Houge made a motion to approve the monthly bills, seconded by Woodward. Neys, Klose, Houge, Woodward, Ova, Marks, and Schwartz voted aye. Motion carried.

Karl Bergh, Park Superintendent, presented his monthly report. Two spaces were added at Lakeside Marina with water and electric hookups. The cabins at Pelican Point were moved, but the porches needed to be rebuilt. New tin was also ordered to replace the roofs on the cabins. All the fishing piers are in, which was two weeks ahead of last year. At both campgrounds, the smaller trash cans were removed so now only the dumpsters are being used. A trailer was converted for spraying that can be pulled behind a pickup, so the pick-up that was used for spraying can be sold. They have been removing dead trees from Joo's Grove and mowing the disc golf course and have gotten several compliments on it.

Commissioner Schwartz discussed haying of the Bureau land at the reservoir. Bergh has had two requests to do the haying. Houge made a motion to allow Travis Lorenz to hay the reservoir land, seconded by Ova. Motion carried.

Bergh discussed tilling at the nursery by Agricovert. No work was done last year so wormwood has taken over. The county's tillage equipment needs repair. Klose recommended contacting the Weed Board and Road Department for help with removing the weeds and tilling the ground.

Ben Smith requested approval to host an event at the Jamestown Reservoir. He would like to hold a sprint triathlon on August 11th, run by the High School Swimming and Diving Team. Neys made a motion to approve the event, seconded by Marks. Motion carried.

Nicole Meland, Auditor/COO discussed the annual evaluation of Interim Park Superintendent Karl Bergh. Reviews need to be to Meland or Shannon Larson by the end of the month.

Meland discussed a bill received from Marlyn Bertsch for snow removal. He requested reimbursement for 31 times of snow removal at \$25.00 per time. Mark Klose suggested tabling the issue to research charges. Ova made a motion to deny the request for reimbursement, seconded by Houge. Roll call vote: Klose, Houge, Woodward, Ova, and Schwartz voted aye. Marks and Neys voted no. Motion carried.

Meland discussed an issue with comp time with the Park Department. There was a previous policy in place to keep track of comp time in a notebook when employees worked more than 40 hours per week. This is against County policy and federal law. Employees are not allowed to use this system, and comp time is capped at 40 hours. Meland suggested paying out the hours accumulated over 40 and leaving 40 hours of comp time. Schwartz made a motion to approve, seconded by Woodward. Houge, Woodward, Ova, Marks, Schwartz, Neys, Klose voted aye. Motion carried.

Project applications for reservoir cabins were presented for Lot 7 Eastside (two applications), Lot 6 Westside, Lot 30 Westside, Lot 33 Westside, and Lot 50 Westside. Houge made a motion to approve the project applications, seconded by Woodward. Motion carried.

At 5:25 p.m., Schwartz made a motion to adjourn, seconded by Neys. Motion carried.

At 5:25 p.m., the Commission meeting was called to order.

A motion was made by Marks, seconded by Neys approve the monthly bills. Ova, Marks, Schwartz, Neys, and Klose voted aye. Motion carried.
