

Official Proceedings of the Stutsman County Commission – June 18, 2019

At 4:42 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Denny Ova, Ramone Gumke, Dave Schwartz, Steve Cichos, and Mark Klose answered the roll call.

Emeline Burkett, Social Services Director, requested permission to submit agreement to zone with Barnes County. Cichos made a motion, seconded by Ova. Schwartz, Cichos, Klose, Ova, and Gumke voted aye. Motion carried.

Jim Fettig, Maintenance Supervisor, discussed two HVAC projects at the Courthouse. One of the boilers is original to the courthouse and needs to be replaced. The fresh air intake system is also original to the building and needs replacement to be more efficient. The pneumatic controls for the heating system also need replaced. These were all budgeted for. Cichos made a motion to approve advertisement for bids for the three projects, seconded by Gumke. Motion carried.

Fettig also discussed a new door at the Extension office. Windows in the building were replaced and came in under budget. Jim would like to use the extra funds to replace the door. Ova made a motion, seconded by Schwartz to approve. Cichos, Klose, Ova, Gumke, and Schwartz voted aye. Motion carried.

Fettig also discussed replacing controls at the Social Services building. There is money in the maintenance budget for it. Schwartz made a motion, seconded by Gumke. Klose, Ova, Gumke, Schwartz, and Cichos voted aye. Motion carried.

Tyler Perleberg, Director of Tax Equalization/Zoning Administrator, discussed a conditional use permit from Knife River Materials. The location is 12 miles south of Jamestown. The Planning and Zoning Committee approved the permit. Schwartz made a motion to approve, seconded by Cichos. Motion carried.

Perleberg also presented an amendment to the Zoning Ordinance for Commercial Surface and Subsurface extraction. This is clarifying some language and adding additional regulations. The Planning and Zoning Committee recommended it for approval. Cichos made a motion, seconded by Ova to approve. Motion carried.

Perleberg presented an amendment to the Zoning Ordinance for Animal Feeding Operations. This change is to make sure we are following new legislation. The Planning and Zoning Committee made a recommendation to approve. Gumke made a motion, seconded by Ova to approve the amendment. Motion carried.

Mickey Nenow, Road Superintendent presented his monthly report. Road restrictions will be taken off soon. The County Road 42 project was started today.

Jerry Bergquist, Emergency Manager/9-1-1 Coordinator discussed membership changes to the Stutsman County Local Emergency Planning Committee (LEPC). The LEPC is suggesting 4 new members and removing 4 members. Schwartz made a motion, seconded by Ova to make the changes. Motion carried.

Bergquist also discussed the purchase of replacement communication center radio consoles. He received cost estimates from Motorola. The State Information Technology Department handled the bidding process. This will be compatible with a state-wide interoperable radio system so all dispatch centers will be connected. The estimate includes three consoles, installation, encryption, and grounding. The total cost will be \$366,456.64. The cost to ITD for connection to the servers is still unknown. Most of the funds can come from the increased 9-1-1 fee and any remainder can come from the revolving loan fund. Schwartz made a motion to approve purchase of the consoles, seconded by Gumke. Ova, Gumke, Schwartz, Cichos, and Klose voted aye.

Robin Iszler, Central Valley Health Unit Director, presented the 2018 Annual Report and the 2020 Budget. These figures will be included in the preliminary budget and approved with the final budget in October.

Alden Kollman from the Stutsman County Museum was present to discuss historical funding, along with representatives from the Frontier Village and Fort Seward. Currently, their mill levy is .14 for historical funding. The maximum levy per statute is .25 mills. Kollman is requesting the full .25 mills, allocated 40% for the museum, 40% for the Frontier Village, and 20% for Fort Seward, which is currently not receiving any funding. The request will be considered with the further budget discussions.

Nicole Meland, Auditor/COO, discussed CDBG grant acceptance for the Streeter Senior Center. Gumke made a motion to accept the grant provided that the Senior Center pays the \$5,000 in administrative fees, seconded by Ova. Gumke, Schwartz, Cichos, Klose, and Ova voted aye. Motion carried.

Meland also presented a review of the recent salary survey and discussed the salary budget. Meland recommends implementing performance reviews for elected officials and adding new growth positions to some departments. She would like to include salary survey adjustments, new growth positions, and a 1.5% cost of living increase in the preliminary budget for consideration.

Schwartz made a motion, seconded by Ova to approve the taxable meals and mid-month bills. Gumke, Schwartz, Cichos, Klose, and Ova voted aye. Motion carried.
