

Official Proceedings of the Stutsman County Commission— July 5, 2022

At 3:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Joan Morris, Steven Cichos, Ramone Gumke, and Mark Klose answered the roll call.

A motion was made by Ova to approve the June 2022 commission meeting minutes, seconded by Morris. Motion carried.

Tom Kleven, St. Paul Township, requested a \$117,000 short term loan to pay Guthmiller and Interstate Engineering for a completed project in St. Paul township. Kleven said FEMA money will be coming shortly but all invoices needed to be paid. A motion was made by Cichos to approve and be paid on the current check run for bills approved at this meeting, seconded by Gumke. Roll call vote: Ova, Gumke, Morris, and Klose voted aye. Motion carried.

Shannon Davis, Human Resources Director, presented a request of grade changes for the Sheriff's Department and States Attorney Office. Morris made a motion to approve changes to positions increasing by one grade effective July 1, 2022, seconded Cichos. This includes Deputy Sheriff 1, Deputy Sheriff 2, Deputy Sheriff 3, Sergeant Deputy Sheriff, and Major/Deputy. Roll call vote: Gumke, Morris, Cichos, Klose, and Ova voted aye. Motion carried.

A motion was made by Morris to approve the grade changes to Assistant States Attorney I and Assistant States Attorney II grade changes effective July 1, 2022, seconded by Gumke. Roll call vote: Morris, Cichos, Klose, Gumke, and Ova voted aye. Motion carried.

Fritz Fremgen, States Attorney, advocated for the grade raises and presented his monthly report.

Jim Fettig, Maintenance Supervisor, presented a prior request to use ARPA money for replacement of the VAV boxes and controls at Social Services. Fettig stated one VAV box has already failed. The request is for \$27,500. A motion was made by Ova to purchase using the ARPA fund, seconded by Cichos. Roll call vote: Cichos, Klose, Ova, Gumke, and Morris voted aye. Motion carried.

Jim Wentland, Road Superintendent presented his monthly report.

Chad Kaiser, Sheriff, requested the purchase of Kenwood single band radios for \$94,391. They are 6-8 months out. The capital purchase is scheduled for 2022. A motion was made by Gumke to approve, seconded by Morris. Roll call vote: Klose, Ova, Gumke, Morris, and Cichos voted aye. Motion carried.

Kaiser provided an update of sheriff's building. Kaiser inspected the ambulance building, currently listed for sale. This building had a new roof five years ago. Kaiser will attempt to get vehicles inside.

Jessica Alonge, Auditor/COO presented appointment of the NDACo Delegate. Alonge was the delegate in 2021. A motion was made by Cichos to nominate Jessica Alonge as the NDACo Delegate, seconded by Ova. Motion carried.

A motion was made by Gumke to approve the special event permits for Hltchin' Post and Gundy's Bar & Grill, seconded by Ova. Motion carried.

At 4:45 p.m. the Commission meeting recessed for the Park Board meeting.

At 4:46 p.m., Chairman Klose called the regular meeting of the Stutsman County Park Board to order. Dennis Ova, Ramone Gumke, Joan Morris, Steven Cichos, Mark Klose, Robert Martin, and Merri Mooridian (via phone) answered the roll call.

A motion was made by Ova to approve the June 2022 meeting minutes, seconded by Gumke. Motion carried.

Alonge stated that she spoke with Andrea from the Bureau of Reclamation regarding the dock permit issue. The Bureau said they have stipulations for their properties but have no say in any decisions by the Park Board. A motion was made by Cichos that no personal property be allowed on park board property, no mowing of park board land, except as allowed by the dock permit, and to abide by all other terms of the existing dock permit, seconded by Martin. Motion carried. Klose suggested review of language in the dock permit.

At 5:00 p.m., Ramone Gumke left the meeting.

A motion was made by Morris that removal of the property line bumper posts are not allowed, seconded by Ova. Motion carried.

A motion was made by Ova to approve the monthly bills, seconded by Martin. Roll call vote: Martin, Mooridian, Ova, Morris, Cichos, and Klose voted aye. Motion carried.
