

Official Proceedings of the Stutsman County Commission – July 17, 2018

At 4:30 p.m., Charmain Mark Klose called the regular meeting of the Stutsman County Commission to order. Denny Ova, Dale Marks, Dave Schwartz, Craig Neys, and Mark Klose answered the roll call.

Keith Domke, President of the Jamestown Marksmanship Education Range, was present to inquire about leasing land at the Stutsman County Fairgrounds. They have been looking for options for an indoor gun range in Jamestown and inquired about land at the Fairgrounds between the law enforcement range and the area where the mud drags are held. County staff will look into whether the desired site is owned by the County or owned/leased by the Fair Association and the board will discuss at a future meeting.

David Bratton, Veterans Service Officer, presented an out of state travel request. He will be traveling to Pierre, South Dakota August 19-25 for the National Association of County Veterans Service Officers training. Neys made a motion to approve, seconded by Marks. Motion carried.

Jessica Moser, Treasurer, presented a request to cancel uncashed warrants and treasurer's checks. These checks are more than 1 year old as of June 30th. They will be cancelled and next year will be sent to the state as unclaimed property. Schwartz made a motion, seconded by Ova. Marks, Schwartz, Neys, Klose, and Ova voted aye. Motion carried.

Moser also requested approval to change the primary bank accounts for Stutsman County. In January, Wells Fargo notified the County that they could no longer waive the service fees for our accounts. The fees are approximately \$10,000 per year. Moser has met with Bank Forward and they are able to meet the County's pledging requirements. Bank Forward fees are estimated at approximately \$2,100 but interest earnings on the accounts will help negate the fees. The accounts would include the savings, primary checking, payroll, inmate, foster care, and CDBG. Schwartz made a motion to switch the primary bank accounts from Wells Fargo to Bank Forward, seconded by Ova. Schwartz, Neys, Klose, Ova, and Marks voted aye. Motion carried.

A special events liquor permit was presented from Gundy's Bar and Grill for a wedding at the Boondocks. Ova made a motion, seconded by Schwartz. Motion carried.

Commissioner Schwartz discussed hiring a temporary park maintenance position for the Parks Department. An employee is out for the foreseeable future on medical leave and the other employees need additional help to keep up on the mowing and garbage removal. Schwartz made a motion to advertise for the position, seconded by Neys. Motion carried.

Nicole Meland, Auditor/COO, presented adjustments to the 2019 preliminary budget. Commissioner Schwartz suggested adding an additional 1% COLA for a cost of \$88,460. There will be a salary survey done next year, and increasing the salaries now could help lessen the increase in future years. Fund balance from the State Highway Aid Fund will be used to fund some of the road projects in 2019. Meland will make the necessary changes and prepare new budget packets for the board to approve at the next meeting.

Ova made a motion to approve the taxable meals and mid-month bills, seconded by Marks. Neys, Klose, Ova, Marks, and Schwartz voted aye. Motion carried.
