

Official Proceedings of the Stutsman County Commission – July 20, 2021

At 3:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Joan Morris, Steven Cichos, and Mark Klose answered the roll call. Ramone Gumke was absent.

Jim Fettig, Maintenance Supervisor, discussed quotes from Trane for a rooftop unit for the Courthouse. The quote is for \$31,500. He has \$30,000 budgeted for replacement. It will also cost less than \$500 if they have to run new electric to the unit. Cichos made a motion to approve the purchase, seconded by Ova. Ova, Morris, Cichos, and Klose voted aye. Motion carried.

Fettig also discussed the air conditioning unit at the Social Services building. One of the coils has gone out and is leaking refrigerant. He has \$16,000 built up in his budget. The replacement will cost \$11,283. Cichos made a motion to approve, seconded by Morris. Morris, Cichos, Klose, and Ova voted aye. Motion carried.

Fettig also discussed moving a wall in the current Treasurer/Recorder's office. Fettig could move the wall with the window out about 3 feet to increase the size and make the office ADA compliant. The cost of the project will be approximately \$6,000. Fettig would like to purchase the carpet soon as there is a remnant available that matches the existing carpet. Morris made a motion to move ahead with the office expansion contingent on it qualifying for the American Rescue Plan funding, and purchase the carpet immediately, seconded by Cichos. Cichos, Klose, Ova, and Morris voted aye. Motion carried.

Jessica Alonge, Interim Auditor/COO, presented a letter from Interstate Engineering requesting comments about the Bison World project. The letter is inquiring about projects or environmental concerns on the proposed site. Ova made a motion to support the Bison World project, seconded by Morris. Motion carried.

Jessica Alonge discussed American Rescue Plan Act Funds. The recommendation from the North Dakota Association of Counties was to claim the funds in order to collect interest. Any interest gained on the funds can be kept by the county for any purpose regardless of whether the funds are used. Alonge would also like to establish a separate fund for the money to be able to easily track it. Alonge also discussed the remaining CARES funds that are currently in the FEMA fund. That money is not earning interest. Morris made a motion to claim ARPA funds and to create two separate funds for the ARPA and the CARES money, seconded by Ova. Klose, Ova, Morris, and Cichos voted aye. Motion carried.

Alonge discussed excess levies for Peterson, St. Paul, and Weld Townships. These townships have outstanding balances with the Road department over \$10,000 for more than 12 months. The townships were sent letters last week giving them a deadline of August 1st to pay their balance.

Alonge discussed the 2022 Preliminary Budget. They hope to have the budget ready by the end of the week. Cichos proposed a special meeting on Tuesday July 27th at 10:00 a.m.

A special event permit was presented by Fred's Den for a wedding at the Masonic Lodge on August 7th. Cichos made a motion to approve, seconded by Ova. Motion carried.

The Commission meeting was recessed for the County Park Board meeting

Official Proceedings of the Stutsman County Park Board – July 20, 2021

At 4:14 p.m., the Stutsman County Park Board meeting was called to order.

Karl Bergh, Park Superintendent, discussed a road closure at the Farmer's Union camp. The camp would like to reduce car traffic through the area while campers are present. They have placed a permanent closure on the road to a back loop on their leased area. They also want to close a road by the playground when they are using the area. Cichos made a motion to provide bumper posts to block the road at the first site, seconded by Ova. Motion carried.

Bergh discussed purchase of a new pumper truck. There is one available for \$31,500 that would be an upgrade from the current truck. They have been budgeting for a replacement in four years for \$50,000. Morris made a motion to approve the purchase of the pumper truck, seconded by Ova. Martin, Houge, Ova, Morris, Cichos, and Klose voted aye. Motion carried.

A project application from Jeff Mooridian was discussed. The issue was tabled until he requests to re-visit the issue.

Cichos questioned whether there was a conflict of interest for cabin owners on the Park Board to approve the bills since there are lease refunds being paid. Martin made a motion that there is not a conflict of interest for board members that are receiving lease refunds, seconded by Ova. Ova, Klose, and Martin voted aye. Motion carried.

Cichos made a motion to approve the monthly bills, seconded by Ova. Morris, Cichos, Klose, Martin, Houge, and Ova voted aye. Motion carried.
