

Official Proceedings of the Stutsman County Park Board – August 7th, 2012

At 3:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Park Board to order. Dale Marks, David Schwartz, Robert Woodward, Craig Neys, and Mark T. Klose answered the roll call. Denny Ova and Mark Schlecht were absent.

Neys made a motion, seconded by Woodward to approve the minutes of the July 2012 meetings. Motion Carried.

A question was raised regarding the billing of Northern Plains. The board thought the bill seemed high. Woodward made a motion, seconded by Schwartz to approve the monthly bills with a follow up on the Northern Plains billing that was in question. Roll call vote: Marks, Schwartz, Neys, Klose, Woodward voted aye.

Dennis Lorenz, Stutsman County Park Superintendent, presented his monthly report. Dennis received two bids for removal of the rebar and foundation at Sandy Beach. Kresbach submitted a quote for \$14,400.00 to remove the rebar and foundation at Sandy Beach at Spiritwood Lake. Guthmiller submitted a quote for \$22,000.00 to remove the rebar and foundation at Spiritwood Lake. Dennis put up signs of danger, ran caution tape around the rebar and put up signs to keep out. Schwartz made a motion, seconded by Marks to table the request until a future time. Motion Carried.

Dennis also received two bids for removal of the old boat ramp at Pelican Point. Kresbach submitted a quote for \$12,800.00 and Guthmiller submitted a quote for \$10,000.00 to remove the old boat ramp at Pelican Point. Dennis had put up signs and people were still using the old boat ramp regardless of the signs. Dennis pulled the old dock out. The area is clearly marked with caution tape and no trespassing signs on both posts. Schwartz made a motion, seconded by Woodward to table the boat ramp removal request. Motion Carried.

Dennis reported that there have been some camping issues at Spiritwood Lake. The campers at Sandy Beach have been using the facilities at Spiritwood Lake. Ted Steckler would like Stutsman County to take care of this issue. The consensus is that Stutsman County can do nothing and that Ted would need to take care of this issue on his own. Dave Schwartz offered to speak with Ted Steckler regarding the camping issues.

The leasing of gravel pit land in Corwin Township was advertised for bids on April 14, 2012. No bids were received. Kenneth Schnieder and Iva Klose are interested in the leasing of the gravel pit land in Corwin Township as joint lessees. They are willing to pay \$550.00 per year for a three year lease. Mary Jane Westerhausen, the previous lessee, indicated that she was no longer interested in leasing the property. Westerhausen paid \$559.00 per year for a three year lease. Marks made a motion, seconded by Neys to accept the offer as presented. Schwartz, Neys, Klose, Woodward, Marks voted aye.

Hugo's Family Marketplace is requesting approval of a special use permit for family fun day at Joo's Grove Area. Per the contract with Kesler, "No vendor, other than permitted concessionaire, shall be allowed to sell merchandise and/or food in the concessionaire's area of management operation. Under the contract for Kesler, his area of operation is listed as "the concessions and campgrounds known as "Lakeside Marina and Campground". The event is within Kesler's area of operation. Hugo's will be selling concessions. Currently, they have three for-profit vendors participating and they will limit it to those three. Hugo's and Ingstad Family Media have met with Mike Kesler regarding his share of the concessions. Mike Kesler requested that he be paid \$100.00 per vendor. Hugo's and Ingstad Family Media have agreed to Mike Kesler's request. Woodward made a motion, seconded by Schwartz to approve the special use permit as presented. Motion Carried.

At 3:57 p.m., a motion to adjourn the Stutsman County Park Board meeting was made by Woodward, seconded by Marks. Motion Carried.

Official Proceedings of the Stutsman County Commission – August 7th, 2012

At 4:00 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dale Marks, David Schwartz, Craig Neys and Mark T. Klose answered the roll call. Dennis Ova was absent.

Marks made a motion, seconded by Schwartz to approve the minutes of the July 2012 meetings. Motion Carried.

Bids were opened for Construction Engineering Services for two grade raise projects on County Road 67, south of Cleveland. The federal aid projects are known as CER-4717(085) and CER-4717(090). The contractor has been selected. Aspen Construction will be doing the project. Stutsman County needs to select an engineering firm to actually do the construction engineering for the project. Two bids were received. The only requirement was to have the bid package clearly marked on the outside of the package with "Construction Engineering Services Proposal". Interstate Engineering failed to meet this requirement. Schwartz made a motion, seconded by Marks to award the bid to Ulteig Engineering, Surveying, and Consulting Services. Roll call vote: Neys, Klose, Marks, Schwartz voted aye.

Neys made a motion, seconded by Marks to approve a local raffle permit for Central ND Rabbit Breeders at Stutsman County Fairgrounds. Motion Carried.

Schwartz made a motion, seconded by Marks to approve a local raffle permit for Pingree Rural Fire Department at 281 Stop. Motion Carried.

Neys made a motion, seconded by Schwartz to approve a beer and liquor license for Scott Anderson dba Cork & Barrel Liquors at Stutsman County Fairgrounds Beer Gardens. Motion Carried.

Mickey Nenow, County Highway Superintendent, presented his monthly report. The Stutsman County Road Department finished chip sealing the roads and are now working on graveling the roads. The culvert crew is putting in culverts. The three paving projects south of Cleveland have been completed. The gravel crushing is scheduled to be done today. The Road Department is putting in overtime every other Friday.

Stutsman County received a letter from Marlin Sabinash and Roger Florhaug, Nogosek Township Chairman making the commission aware of a possible illegal drain located in Section 27 of Nogosek Township, Stutsman County. The drain might have contributed to the flooding of county and township roads in northern Stutsman County. This matter was presented to NRCS and their initial investigation supports the claim of this being an illegal drain. Stutsman County cannot determine this at this time; it has to go through the Water Resource Board. Neys made a motion, seconded by Schwartz to approve Stutsman County sending a letter of request to look into this matter to the Water Resource Board. Motion Carried.

Marks made a motion, seconded by Schwartz to approve the bills for payment. Roll call vote: Klose, Marks, Schwartz, Neys voted aye.

Bids were opened for Griffin Township Sites 201, 213, 214, 208, and 209 grade raises. Reiner Contracting Inc., site 201 with addendum one is \$254,000.00 less a \$125,000.00 discount if all sites are selected; site 208 is \$179,231.22; site 209 is \$215,508.23; site 213 is \$183,669.38; and site 214 is \$106,555.91. Gratech Company, site 201 with addendum one is \$318,806.54 less a \$50,000.00 discount if all sites are selected; site 208 is \$188,570.46; site 209 is \$267,795.30; site 213 is \$208,866.69; and site 214 is \$131,011.28. Naastad Brothers Inc., site 213 is \$265,350.65 and site 214 is \$128,929.95. R.J. Zavoral, site 201 is \$414,248.60 less a discount of \$50,000.00 if all sites are selected; site 208 is \$286,349.95; 213 is \$258,262.05; site 209 is \$352,807.65; and site 214 is \$143,675.25. Guthmiller Earthmoving, site 201 is \$222,335.60 less a discount of \$38,560.00 if all sites are selected; site 208 is \$134,770.00; site 209 is \$161,813.20; site 213's bid was not accepted due to an incorrect bidder's bond; site 214 is \$75,066.90. RTS Shearing, site 201 is \$268,300.00 less a discount of \$7,000.00 for each site for a total of \$35,000.00 if all sites are selected; site 208 is \$179,375.00; site 209 is \$212,200.00; site 213 is \$185,150.00; site 214 is \$89,275.00. Stutsman County is acting as an agent for Griffin Township. The bids will be forwarded to Griffin Township. Griffin Township will analyze and award the bids.

Jerry Bergquist, 911 Emergency Manager/Coordinator presented information on the award of 911 bids for Richland and Stutsman County. Technology has changed considerably over the years since Stutsman County last purchased 9-1-1 equipment in November 1999. A new requirement that is state law is every 9-1-1 center has to have a backup 9-1-1 location in case of an emergency. Richland County and Stutsman County received two bids. Minnkota Communications/Jamestown Communications did not meet bid specifications. Independent Emergency Services submitted a bid for a total of \$351,407.21 with Stutsman County's share being \$167,757.69 and Richland County's share being \$183,649.52. Jerry stated that it was very hard to determine what the total cost would be, however, it would not exceed the combined total of \$351,407.21. The installation of the 911 equipment will hopefully be in December. Schwartz made a motion, seconded by Neys to accept the bid from Independent Emergency Services as presented not to exceed a combined total of \$351,407.21. Roll call vote: Marks, Schwartz, Neys, Klose voted aye.

At 4:52 p.m., the Stutsman County commission meeting recessed and will continue in meeting room three in the lower level of the Law Enforcement Center.

At 5:04 p.m., the Stutsman County commission meeting reconvened.

Fritz Fremgen, State's Attorney, presented information on the Gahner mobile home tax case settlement stipulation. The request is to return \$2,000.00 to Green Tree Servicing LLC. Marks made a motion, seconded by Schwartz to approve to return \$2,000.00 and enter into the stipulation for Settlement/Dismissal with Green Tree Servicing. Roll call vote: Schwartz, Neys, Klose, Marks voted aye.

David Prachar, Jail Consultant, LLC, presented his Jail Staffing Analysis and Operational Assessment. Mr. Prachar toured the facility on May 30, 2012 and found that the facility is clean, quiet, and safe. He commended the Law Enforcement Center staff on this accomplishment. The staffing analysis recommendations are as follows: Define positions and titles as well as having four assigned fixed posts: Control Officer Post, Sergeants Post, Intake/Rover Post, and Housing Unit Post; determine the type of shift the LEC will use – Prachar recommends using an eight hour shift for administration, the medical and maintenance department and the custody department should use a 12 hour shift; determine which standards are applied according to the North Dakota Rules and regulations; determine the shift relief factor for net annual hours worked (NAHW); determine support services delivery and emergency response time in case of emergencies; and lastly, a staff coverage plan would need to be developed. A recommendation is to promote two correctional officer staff to sergeant. Part-time staff would be scheduled or called in only when permanent staff on rotation would be scheduled off for leave, etc. A recommendation of a job-task analysis on the deputy administrator and the administrative assistant position should be completed.

At 6:43 p.m., the Stutsman County commission meeting recessed.

At 6:53 p.m., the Stutsman County commission meeting reconvened.

The operational assessment recommendations are as follows: Update the policy and procedure

manual; increase and maintain supervisory coverage twenty-four hours seven days per week; facility keys – create master interior and exterior keys, communicate via radio with control center; training – assign a staff member to be the Training Coordinator, develop a training plan; establish security posts; and lastly, the visiting area - implement a video visitation system.

Casey Bradley, COO, discussed some of the proposed changes for the LEC Department. Two employees will need to be promoted to Sergeant, establish twelve full-time correctional officers, and to change the status of permanent part-time staff to casual part-time status dependent upon their utilization. Casey made some recommendations to establish part-time pay rates for each potential position, to look at shift differentials to assist in recruiting and retaining staff, adopt a set pay rate for part-time staff, and to create criteria for advancement for part-time staff based on training rather than time in a grade.

At 7:34 p.m., the Stutsman County commission meeting recessed to move the meeting back to the commission meeting room.

At 7:40 p.m., a motion to adjourn was made by Schwartz, seconded by Neys. Motion Carried.
