

Official Proceedings of the Stutsman County Commission – August 7, 2018

At 4:00 p.m., Chairman Mark Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys, and Mark Klose answered the roll call.

Marks made a motion, seconded by Schwartz to approve the minutes of the July 2018 meetings. Motion carried.

Chad Kaiser, Stutsman County Sherriff discussed personnel issues in the department. Deputy Matt Thom has resigned. Due to his resignation, a decision needs to be made about the K-9 unit. The dog, Dreamos is scheduled to retire in 2021. Kaiser requested that the dog be retired to Deputy Thom which is standard practice. Ova made a motion to return Dreamos to Matt Thom for \$1.00 along with Thom entering a hold harmless agreement with the County, seconded by Schwartz. Ova, Marks, Schwartz, Neys, and Klose voted aye. Motion carried.

Mickey Nenow, Road Superintendent, presented his monthly report. They are still gravelling and doing work on County Road 67 North of Cleveland. They are also repairing culverts and trimming trees along county roads.

Commissioner Schwartz discussed the crossover road from Hwy 9 to County Road 62 between Stutsman and Barnes counties. The townships have been maintaining the road but it gets a lot of traffic. Barnes County would like to improve the road. In order to do that, Stutsman County would have to take possession of our part of the road from the township. It would remain a gravel road and wouldn't require much more maintenance. Barnes County has said they would be willing to blade the entire road in the winter. The agreement would be contingent on Barnes County approving the transfer.

Fritz Fremgen, State's Attorney, presented his monthly report.

Nicole Meland, Auditor/COO, presented a list of the absentee and early vote center workers for the November General Election. Neys made a motion, seconded by Schwartz to approve the poll workers for absentee and early voting. Motion carried.

Meland also presented a list of the polling locations and hours. There will be three rural locations in Pingree, Kensal, and Medina, along with the vote center at the Civic Center in Jamestown. All locations will be open from 7am-7pm on November 6. Absentee voting begins on September 20th through November 5th. Early voting will be from 10/22-10/26 and 10/29-11/2 at the Courthouse from 8am to 5pm. Ova made a motion, seconded by Marks, to approve the polling locations and hours. Motion carried.

Meland presented a renewal contract from Jamestown Community Correction Program. They are requesting a 5 cent increase from \$1.30 to \$1.35. The LEC governing authority voted to approve. Schwartz made a motion, seconded by Ova, to approve the increase. Marks, Schwartz, Neys, Klose, and Ova voted aye. Motion carried.

Meland presented a letter of support for Jamestown Rural Fire District for their USDA loan. The levy increase for the district passed at the special election. This is a letter showing community support for the project. Ova made a motion, seconded by Marks to approve signing the letter. Motion carried.

Meland discussed a re-count for the Secretary of State race in the primary election. The North Dakota Supreme Court ordered a recount. The re-count board will consist of the Commission chair, State's Attorney, and Recorder. The date for the re-count has not yet been set.

Meland presented the updated version of the Preliminary budget. There is a net increase in revenues of \$788,086 and a net increase in expenses of \$3,015,130. The budget includes a salary increase of 2% COLA and 2% step. The County mill levy will decrease by 0.83 mills and will have an overall net decrease of fund balances of \$2,077,601. Schwartz made a motion to approve the preliminary budget as presented, seconded by Neys. Schwartz, Neys, Klose, Ova, and Marks voted aye. Motion carried.

At 4:37, the Stutsman County Commission Meeting recessed for the County Park Board meeting.

A project application for Reservoir cabin, Lot #11 Westside was presented for the addition of a garage. Ova made a motion, seconded by Woodward. Motion carried.

Jessica Alonge, Deputy Auditor/Recorder discussed a grant application with Jamestown Tourism. The campground committee met with the chair of Barnes County Park Board and has been discussing options to expand Lakeside Marina Campground. There is a feasibility grant through Jamestown Tourism that would pay for KLJ to begin the design plan for the possible expansion. This would give us an estimate on how much the expansion would cost which would help when applying for grant funding.

A lease transfer for Reservoir cabin Lot #3 Eastside was presented. Ryan and Jessica Skjeret have bought the cabin and a Bill of Sale has been recorded. Houge made a motion to approve the transfer pending payment of the lease and permit fees, seconded by Ova. Motion carried.

Commissioner Schwartz discussed a call from Eric Nordstrom at Spiritwood Lake who wants to remove a garage and rebuild a new garage in a different location. Schwartz made a motion to approve the garage replacement, contingent on approval from the City of Spiritwood Lake, seconded by Marks. Motion carried.

Ova made a motion to adjourn the Park Board meeting, seconded by Schwartz. Motion carried.

At 4:57, Klose called the County Commission meeting back to order.

Marks made a motion, seconded by Neys to approve the monthly bills. Klose, Ova, Marks, Schwartz, and Neys voted aye.
