Official Proceedings of the Stutsman County Commission—September 19, 2023

At 3:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Jerry Bergquist, Chad Wolsky, Joan Morris, and Mark Klose answered the roll call.

The Pledge of Allegiance was recited.

A motion to appoint Levi Taylor to fill the vacancy on the commission, with a majority vote, was made by Wolsky, seconded by Bergquist. Motion carried.

Taylor then took his place with the board, making all Commission members present.

A motion to have Taylor fill the position of Commissioner Steven Cichos on various boards until the reorganization of the Commission was made by Bergquist, seconded by Wolsky. Motion carried.

Jessica Alonge, Auditor/COO, gave an update on the courthouse facility grant. The quotes were given in October 2022 by Smitty's, which has since been purchased by Goldade Flooring. It was discovered that the original quote for flooring was 198 square feet short, causing a difference of \$1,373 in the flooring amount. Alonge requested that the amount be taken from the building fund, as the grant was only for the amount of the original quote. A motion to approve the request was made by Wolsky, seconded by Bergquist. Roll call vote: Bergquist, Wolsky, Morris, Taylor, and Klose voted aye. Motion carried.

Shannon Davis, HR Director, presented the 2024 NDPHIT health insurance plan options. The current plan came in with a higher increase than expected, so a custom plan was created with a lower deductible, but higher out of pocket max, which would only be a 5.7% increase for both the county and the employee. Approval is needed by September 20. Davis is in favor of going with the custom plan, with the option for employees to purchase a supplemental GAP plan if they chose to do so. A motion to move ahead with the custom plan and medical gap plans 1 & 2 effective January 1, 2024, was made by Bergquist, seconded by Wolsky. Roll call vote: Wolsky, Morris, Taylor, Klose, and Bergquist voted aye. Motion carried.

Bergquist gave an update on the possible restructuring of the park board. All 5 townships that border park board land are willing to serve on the park board. Jamestown Parks and Recreation chose not to be a member of the park board. Bergquist would like to see another township designee in the parks and recreation position since so many are interested. A motion to restructure the park board, effective January 1, 2024, to include 2 commissioners, 3 townships appointees and 2 resident citizens or members at large positions was made by Bergquist. Motion died for lack of a second.

Chad Kaiser, Sheriff, requested permission to purchase a vehicle. The department's spare vehicle needs \$15,000 in repairs. Wilhelm Chevrolet will take the vehicle to auction, and they are estimating it will bring about \$8,000 - \$9,000. Alonge informed the commission that there are 2 vehicle purchases budgeted for the year, with one already being purchased leaving a balance of \$47,748. Wilhelm was able to find a 2024 Chevrolet pickup for \$52,765. Kaiser will get quotes from Stoudt's to see if they have anything available, and will bring those numbers to the October 3, 2023, meeting.

Alonge presented the proposed joint powers agreement with NDACo for the collection and distribution of 911 fees, starting January 1, 2024. Emergency management staff are interested in the agreement as it would cut down on paperwork not only in their department but also for first floor courthouse staff. Kaiser is on the NDACo board, and they will not be charging any additional service fees to the counties. A motion of interest to join the joint powers agreement for collection of 911 payments, pending clarification, was

made by Morris, seconded by Wolsky. Roll call vote: Morris, Taylor, Klose, Bergquist, and Wolsky voted aye. Motion carried.

Alonge presented the Peterson Township excess mill levy for payment of road department invoices carrying a balance of over \$10,000 for over 1 year. This puts the levy for Peterson Township at 27 mills for the township general fund and 9 mills for their debt to the county. A motion to approve was made by Morris, seconded by Bergquist. The current outstanding balance for road department bills from the townships is \$847,876 as of September 12. Jim Wentland, Road Superintendent, stated that once a township balance reaches \$50,000 the department no longer does any work for that township until payment on the account is made. No interest is charged to the township on these bills. Roll call vote: Taylor, Klose, Bergquist, Wolsky, and Morris voted aye. Motion carried.

A special meeting will be held on Tuesday, September 26, 2023, at 8:00 a.m. for the 2024 budget discussion, which gives Taylor a chance to familiarize himself with the budget. Alonge informed the board that 2,900 parcels in Medina Ambulance District were sent amended estimated tax notices, due to incorrect mill levy calculation.

Alonge requested a promotion for Deputy Auditor Stephanie Anderson, based on the requirements of the 2019 promotion policy. Anderson has been employed with the county since 2019 starting as the Administrative Assistant at Extension and transferring to the Auditor's Office in March of 2022. She began cross training in the Treasurer's Office in the spring and has completed all requirements for the promotion. A motion to approve the promotion to a grade 10, step 5, effective October 1, 2023, was made by Wolsky, seconded by Bergquist. Roll call vote: Klose, Bergquist, Wolsky, Morris, and Taylor voted aye. Motion carried.

At 4:32 p.m., the commission meeting recessed for the park board meeting.
