Official Proceedings of the Stutsman County Commission— October 1, 2024

At 9:00 a.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Jerry Bergquist, Joan Morris, Mark Klose, Levi Taylor (via telephone) and Chad Wolsky (via telephone) were present.

The Pledge of Allegiance was recited.

Jessica Alonge, Auditor/COO, presented election updates and reminders. She reminded voters to make sure their ID is up to date. Applications for absentee ballots are currently available, along with absentee ballots at the Auditor's Office. Early vote will be held October 28- November 1, from 8:00 a.m. – 5:00 p.m. and November 2 from 9:00 a.m. – 1:00 p.m. at the courthouse. The entrance for the November 5 election will be the north ground level doors at the Civic Center.

A motion to approve the September 2024 meeting minutes was made by Bergquist, seconded by Morris. Motion carried.

Alonge gave an update on the Generator Project. She stated that all invoices for the Generator Project have been paid and that Daniel Schwartz, President/CEO of Nexus Planning & Consulting has sent out his final billing for the administrative piece of the grant. He will submit all information for reimbursement through the grant when he receives all check and invoice information from the auditor's office.

Fritz Fremgen, State's Attorney, presented his monthly report. A new employee will be starting in his office on October 16, 2024. Fremgen is waiting for an opening in his schedule to work on the dock research for the Park Board.

Levi Taylor, County Commissioner, requested to have interested parties submit written comments to the commission pertaining to the proposed transmission line amendment to the zoning ordinance. Alonge explained that a notice could be published in the newspaper for at least two consecutive weeks, and the auditor's office could receive hand delivered or mailed written comments on the subject. Kris Koch, Ottertail Power Company, requested that the comment period be 45 days to allow utility companies time to meet on the matter also. Tyler Perleberg, Tax Equalization Director, indicated that the current Ottertail Power Company project would only affect two residential properties in Montpelier Township. A motion to initiate a written public comment period, lasting 45 days from October 1, 2024, in which comments must be hand delivered or mailed to the auditor's office was made by Taylor, seconded by Bergquist. Roll call vote: Bergquist, Wolsky, Morris, Taylor and Klose voted aye. Motion carried.

Alonge informed the commission that the tax foreclosure sale will be held at 10:00 a.m. November 19, which may interfere with the commission meeting. A decision was made to allow Alonge to decide the time for the commission meeting.

Alonge then presented the list of properties currently going to the tax foreclosure sale that will need appraisal prices set by the commission. Taylor will appraise the property in Ypsilanti, Morris will take the City of Jamestown parcels, and Bergquist will appraise the remaining properties with the assistance of Perleberg.

The tax foreclosure hearing will be held on October 15 during the regular commission meeting.

Alonge requested the appointment of the general election poll workers including absentee poll workers on election day, early vote, vote center staff at the civic center and vote center staff at the Medina

location. A motion to approve the lists of poll workers as presented was made by Morris, seconded by Bergquist. Unanimous aye vote. Motion carried.

A discussion was held on the fees for beer and liquor licenses. The fee has not changed since before 2012. A motion to change the beer license amount from \$100 to \$200 and the liquor license fee from \$400 to \$500 was made by Bergquist, seconded by Morris. Roll call vote: Wolsky, Morris, Taylor, Klose, and Bergquist voted aye. Motion carried.

Stutsman County passport photo fees are currently much lower than surrounding counties and retailers. A motion to change passport photo fees from \$10.00 to \$15.00 for 2025 was made by Morris, seconded by Bergquist. Roll call vote: Morris, Taylor, Klose, Bergquist, and Wolsky voted aye. Motion carried.

Alonge presented that ARPA funds must be obligated by end of year. A contract is needed in order for the funds to be obligated. \$800,000 has been allocated for the grade raise for the bridge to the island. The box culvert funding was approved 100% through a state grant. No decision will be made by the board until after speaking with Mike May from Interstate Engineering.

The road department has \$2,193,052 remaining in ARPA funds. The most immediate need for these funds is a 4-mile stretch from the Foster County line to county road 44 for paving on county road 67. The estimate from Interstate Engineering was \$2,078,000. The funds must be committed by the end of the year. A motion to allow Wentland to advertise for bids for this project was made by Morris, seconded by Bergquist. Unanimous aye vote. Motion carried.

Alonge requested to transfer from \$87,969.01 to the road department and \$7,500.24 to the LEC maintenance fund from the ARPA fund. A motion to approve the transfers, as of September 30, 2024, was made by Bergquist, seconded by Wolsky. Roll call vote: Taylor, Klose, Bergquist, Wolsky, and Morris voted aye. Motion carried.

Josh Smaage, IT Director, is waiting for one quote, but several of his projects have come in higher than originally budgeted.

At 10:28 a.m., the Commission recessed for the County Park Board meeting.

Karl Bergh presented a playground project update. Farmers Union has approved a request for funding. The formal order form has been received and the order must be paid in full upon placing of the order. The equipment will be received by January or February. The invoice total is \$63,423.33 with grant approval and shipping. A motion to approve the purchase was made by Wolsky, seconded by Steinberger. Roll call vote: Klose, Steinberger, Mooridian, Bergquist, Wolsky, Morris, and Taylor voted aye. Motion carried.

Bergh also requested to place the order for the handicap accessible double vault toilet for the 2025 project. The quote came in between \$25,000 and \$27,000 depending on the exterior finish. Contributions were made by Garrison Diversion and Farmers Union. Payment would be due after installation in 2025. A motion to approve the request was made by Bergquist, seconded by Steinberger. Roll call vote: Steinberger, Mooridian, Bergquist, Wolsky, Morris, Taylor, and Klose voted aye. Motion carried.

A motion to approve the monthly park bills was made by Mooridian, seconded by Steinberger. Roll call vote: Mooridian, Bergquist, Wolsky, Morris, Taylor, Klose, and Steinberger voted aye. Motion carried.
