

Official Proceedings of the Stutsman County Commission – October 19th, 2015

At 8:05 a.m., Chairman Klose called the mid-month meeting of the Stutsman County Commission to order. Mark T. Klose (arrived late), Craig Neys, and David Schwartz answered the roll call. Dennis Ova and Dale Marks arrived late.

Neys made a motion seconded by Schwartz to approve the member changes for the Grievance and Wage and Benefit Committees. Motion carried.

Dell Horn, Community Correction Program, requested approval of an agreement between Jamestown Community Correction Program and Stutsman County. Horn put in a change for a 25% increase from \$1.00 to \$1.25. Horn compared other counties to Stutsman. It is on a calendar year contract. The intent of the program was to incentivize use, to give them an incentive to get people to do it. The consensus is to table the request in order to get more information.

Lyndsey Michel, Accounts/Property Coordinator for Stutsman County Auditor’s Office, presented the list of foreclosure properties which includes the minimum bid requirements. The property auction will take place November 17th, 2015 at 10:00 a.m. in the courthouse. Schwartz made a motion, seconded by Neys to approve the foreclosure properties, the minimum bid prices, the time, date, and location of the auction. Motion carried.

Jerry Bergquist, Emergency Manager/9-1-1 Coordinator, requested consideration of a burn ban. Of the nine Fire Chiefs that were polled, seven of them want to see a burn ban put in place. Bergquist stated the Fire Chiefs want to bring a higher level of awareness to the public. They mainly want to bring attention to how and when they burn. Commissioner Schwartz stated the ban needs to be redone to be more effective. Jerry discussed the possibility of an ordinance. This would be an awareness type of declaration and burn ban proclamation. Commissioner Klose can sign a temporary burn ban for seven days. It’s looking like this won’t be an issue until next year. It was suggested the Jamestown Sun should put an article in the paper that draws attention and gives facts for the public regarding the burn ban.

Connie Ova, JSDC (Connie was not present, Klose spoke on her behalf.) proposed a resolution to participate in the Red River Valley Water Supply Pipeline. This is a resolution that would indicate Stutsman County’s interest in participating to get water from the Missouri River over here when they start developing it. The county is short on industrial use of water. The intent of the resolution is that the county is interested in the concept and it doesn’t spend any money; the county is interested in this concept. Ova made a motion, seconded by Schwartz to approve the request as presented. Motion carried.

Schwartz made a motion, seconded by Neys to approve the taxable meals and mid-month bills. Roll call vote: Ova, Marks, Schwartz, Neys, and Klose voted aye.

At 8:42 a.m., Commissioner Klose read the legal authority for closing this portion of the meeting was North Dakota Century code section 44-04-19.1 subsections 2, 5, and 9 and section

44-04-19.2. The topic of this session is attorney consultation regarding threatened or pending litigation regarding zoning at Spiritwood Lake. Neys made a motion, seconded by Ova to close the regular county commission meeting and enter into executive session for attorney consultation related to discuss reasonable, predictable or pending civil litigation. Roll call vote: Marks, Schwartz, Neys, Klose, and Ova voted aye. The executive session was attended by Commissioners Klose, Ova, Marks, Schwartz and Neys, State's Attorney Fritz Fremgen, and Auditor/COO Bradley.

At 9:06 a.m., a motion made by Marks, seconded by Schwartz to authorize Auditor Bradley and State's Attorney Fremgen to work with an outside attorney to pursue possible litigation for the rejection of the county's zoning request. Fremgen and Bradley will update the board. NDIRF was contacted to defend the County regarding the threatened litigation regarding the denial of their zoning request from the current leaseholders. Roll call vote: Schwartz, Neys, Klose, Ova, and Marks voted aye.

At 9:07 a.m., a motion to adjourn was made by Schwartz, seconded by Ova. Motion carried.
