

Official Proceedings of the Stutsman County Park Board— October 21, 2025

At 8:30 a.m., Vice-Chairman Wolsky called the regular meeting of the Stutsman County Park Board to order. Ben Tompkins, Mike Hansen, Chad Wolsky, Levi Taylor (via telephone), and Merri Mooridian answered roll. Amanda Hastings and Henry Steinberger were absent.

The Pledge of Allegiance was recited.

At 8:31 a.m. Steinberger joined via telephone.

No public comments were presented.

A motion to approve the agenda was made by Mooridian, seconded by Tompkins. Unanimous aye vote. Motion carried.

Henry Steinberger, Park Board member, gave an update on the kayak launch stations. The docks that were put in needed an extension due to the sloping of the shore. ABC Boat Docks made some 12' extensions, which cost an additional \$5,000 per dock. In order to offset the cost, Steinberger recommended skipping the purchase of one of the docks to make up for the cost difference, since Lazy Fish just installed a launch station. A semi load of picnic tables has been received as well.

Dylan Kleinjan, Park Superintendent, presented a request to purchase a 2026 Ranger 1000, that is budgeted for 2026. The price of the unit is \$29,999 but will be \$32,000 after the first of the year. A motion to approve the purchase was made by Tompkins, seconded by Mooridian. Roll call vote: Tompkins, Hansen, Wolsky, Taylor, Mooridian and Steinberger voted aye. Motion carried.

Jessica Alonge, Auditor/COO, presented Park Portfolio updates. The portfolio is working on the master plan with Interstate Engineering on a survey that will be sent to the residents of the county to get feedback on park related items.

Alonge then presented an update on the Pelican Point bathhouse contract. The project is currently awaiting setback approval from the state. The portfolio requests permission to work with Interstate Engineering for the project with an estimated fee of up to \$25,000. A motion to enter into contract with Interstate Engineering for the bathhouse was made by Tompkins, seconded by Hansen. Roll call vote: Hansen, Wolsky, Taylor, Mooridian, Steinberger, and Tompkins voted aye. Motion carried.

The vault toilet project is complete. The grant reimbursement request will be submitted to Garrison Diversion by the end of the month. The playground equipment installation is complete.

Alonge informed the board of an invitation received from WBI Energy for their public meetings to landowners. The meeting in Jamestown will be November 19th from 5:00 p.m.-7:00 p.m. The information will be posted on the county website and Facebook page.

A motion to approve the mid-month bills was made by Tompkins, seconded by Mooridian. Roll call vote: Wolsky, Taylor, Mooridian, Steinberger, Tompkins and Hansen voted aye. Motion carried.

Official Proceedings of the Stutsman County Commission— October 21, 2025

At 8:49 a.m., Vice-Chairman Wolsky called the regular meeting of the Stutsman County Commission to order. Ben Tompkins, Mike Hansen, Chad Wolsky and Levi Taylor (via telephone) answered roll. Amanda Hastings was absent.

No public comments were presented.

A motion to approve the agenda was made by Hansen, seconded by Tompkins. Motion carried.

Alonge began the appraisal hearing for tax foreclosure properties for the 2025 foreclosure sale. NDCC states that the minimum bidding must be enough to cover the property taxes owing from 2022 through 2024, including penalty and interest, plus the estimate for the 2025 year. A motion to appraise all properties at the minimum sales price was made by Tompkins, seconded by Hansen. Roll call vote: Taylor, Tompkins, Hansen and Wolsky voted aye. Motion carried.

Corry Shevlin, CEO, JSDC presented an incentive request for Cavendish Farms, for their \$150,000,000 renovation, with the county share being \$100,000. A motion to approve the request was made by Taylor, seconded by Tompkins. Roll call vote: Tompkins, Hansen, Wolsky and Taylor aye. Motion carried.

Shevlin also provided an update on recent JSDC projects.

Wolsky, Hansen, and Taylor attended the Crystal Springs informational meeting in Steele and obtained a lot of information on the project.

Jesse Christianson, Highway Superintendent, presented a request to purchase a v plow for emergency use, which is in the capital budget for 2026. The purchase amount is \$21,835, and \$24,000 was originally budgeted. A motion to approve the purchase was made by Tompkins, seconded by Hansen. Roll call vote: Hansen, Wolsky, Taylor and Tompkins voted aye. Motion carried.

Christianson also requested to submit applications for special road funding projects. The grant is for AHL roads only and would be an 80/20 split with NDDOT. A motion to apply for the grant, and decide which project to complete if awarded, was made by Tompkins, seconded by Hansen. Roll call: Wolsky, Taylor, Tompkins, and Hansen voted aye. Motion carried.

Christianson has been working with Daren Peterka, Instate Engineering for a water drain, south of Cleveland for Weber Lake. He is requesting to enter into contract with Interstate Engineering, for a phase-one feasibility study, up to \$41,000. Taylor suggested talking to the Water Resource Board for funding assistance. Christianson and Peterka will attend the Water Resource Board meeting on October 29 to request the funding.

Shannon Davis, Human Resource Director, reminded the board that the performance reviews for the Auditor, Park Superintendent, and Highway Superintendent are due by November 10th.

Davis will also be advertising two openings on the Weed Board, two openings on the Water Resource Board, and two unfilled positions on the Zoning Board.

Davis also provided reminders on open enrollment dates, and the annual drug free workplace training video.

Chad Kaiser, Sheriff, stated that the Back the Blue grant funds have been received, and funds will be distributed to all licensed peace officers in the next month.

Alonge presented information for the creation of the ND I VOTED STICKER contest. All ages can participate, and packets are available at the Auditor's Office.

Alonge also stated that beer and liquor license applications will be sent out at the end of the month and presented the current license fees. No action was taken by the board.

A motion to change the fees for fireworks permits from \$20 to \$250 was made by Taylor, seconded by Tompkins. Roll call vote: Taylor, Tompkins, Hansen, and Wolsky voted aye. Motion carried.

A motion to approve the mid-month bills and taxable meals was made by Tompkins, seconded by Hansen. Roll call vote: Tompkins, Hansen, Wolsky and Taylor voted aye. Motion carried.
