

Official Proceedings of the Stutsman County Commission – October 23, 2018

At 4:35 p.m., Chairman Klose called the meeting to order. Dennis Ova, Dale Marks, David Schwartz, Craig Neys and Mark Klose answered the roll call.

Nicole Meland, Auditor/COO, presented the 2015 tax foreclosure properties. Neys made a motion, seconded by Schwartz to approve the presented appraised values. Roll call vote: Marks, Schwartz, Neys, Klose and Ova voted aye. Motion carried.

An application to change an agricultural district to a residential community zoning district was presented by Tyler Perleberg, Tax Director. Marks made a motion, seconded by Schwartz to approve the presented application. Roll call vote: Schwartz, Neys, Klose, Ova and Marks voted aye. Motion carried.

Josh Bond, Staff Appraiser, presented an abatement application for parcel number 27-0723030. Bond is requesting the prior true and value of \$246,600.00 be changed to \$12,400.00 due to the property qualifying for farm residence exemption. Schwartz made a motion, seconded by Ova to approve the presented value. Roll call vote: Neys, Klose, Ova, Marks and Schwartz voted aye. Motion carried.

Abatement applications for parcel number 17-1040000 were presented by Bond for 2017 and 2018 due to property qualifying for farm residence exemption. A value has to be recalculated for the property. A motion to approve the presented abatement applications for farm residence exemption was made by Ova, seconded by Schwartz. Roll call vote: Klose, Ova, Marks, Schwartz and Neys voted aye. Motion carried.

Jerry Bergquist, Emergency Manager / 9-1-1 Coordinator, presented the membership changes to the Stutsman County Local Emergency Planning Committee (LEPC). Schwartz made a motion to approve the changes, seconded by Neys. Motion carried.

Acceptance of the Hazardous Materials Emergency Preparedness (HMEP) Grant Award was tabled for the next commission meeting.

Josh Smaage, Director of IT, requested an upgrade for the keyless entry system. Ova made a motion to approve the request, seconded by Marks. Roll call vote: Ova, Marks, Schwartz, Neys and Klose voted aye. Motion carried.

Window replacements bids for the Extension Office were presented by Jim Fettig, Courthouse Maintenance Supervisor. Schwartz made a motion to go with the lowest bid, seconded by Marks. Roll call: Marks, Schwartz, Neys, Klose and Ova voted aye. Motion carried.

Meland discussed the 2017 Audit Report. There were no findings.

An updated election poll workers list was presented. Ova made a motion, seconded by Schwartz to approve the updated list. Motion carried.

Dave Schwartz, Commissioner, requested holiday closures for the following dates: November 23, 2018 and December 24, 2018. A motion to approve the requested holiday dates was made by Schwartz, seconded by Ova.

A request to pay the final 2018 Regional Council dues was made. Schwartz made a motion to approve the request, seconded by Neys. Roll call vote: Schwartz, Neys, Klose, Ova and Marks voted aye. Motion carried.

Schwartz made a motion, seconded by Marks to approve the mid-month bills and taxable meals. Roll call vote: Neys, Klose, Ova, Marks and Schwartz voted aye. Motion carried.
