Sheriff Orr stated that he has had Jerry Mayer in to work a couple of days to help get caught up on civil papers. He also requested permission to allow the office deputies some overtime to get caught up on the data entry of the civil papers. A motion to allow a maximum of 20 hours of overtime each for the two office deputies was made by Marks, seconded by Ova. Roll call vote, Ova, Marks, Schwartz, Neys and Klose voted aye. Motion carried.

A motion to approve the loan payment of \$72,000 to Homer Township for the paving of the Hidden Valley road at 5% interest for term of 10 years was made by Marks, seconded by Ova. Motion carried.

Ova made a motion seconded by Neys to adjourn. At 8:36 a.m., the mid-month meeting of the Stutsman County Commission was adjourned.
