

Official Proceedings of the Stutsman County Commission – November 16, 2021

At 3:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Ramone Gumke (via phone), Joan Morris (via phone), Steven Cichos (via phone), and Mark Klose Answered the call.

Jim Fettig, Maintenance Supervisor, requested approval to purchase a snowblower for up to \$1,200, and a backpack vac and buffer in the amount of \$4,500.00 to \$4,700.00. There is \$6,650 left in the budget for the backpack vac and buffer, and \$5,266.00 left in the joint maintenance account for the snowblower. Cichos made a motion to approve the purchase, seconded by Ova. Ova, Gumke, Morris, Cichos, and Klose voted aye. Motion carried.

Chad Warner, Tax Assessor, presented an abatement request for Parcel #16-4000740. Warner recommends reducing the true and full value from \$38,600 to \$23,700.00. Ova made a motion to approve the request, seconded by Cichos. Gumke, Morris, Cichos, Klose, and Ova voted aye. Motion carried.

At 3:37p.m., the County Commission meeting recessed for the County Park Board meeting

Official Proceedings of the Stutsman County Park Board – November 16, 2021

At 3:37 p.m., Chairman Klose called the regular meeting of the Stutsman County Park Board to order. Dennis Ova, Ramone Gumke (via phone), Joan Morris (via phone), Steven Cichos (via phone), Mark Klose, Robert Martin, and Jason Houge were present.

Bob Martin questioned whether the proposed lease for the marina building should be made to the public instead of continuing negotiations with Lucas Dockter. Cichos made the motion to continue with Lucas Dockter's proposal and not open the lease to the public. Gumke seconded. Morris, Cichos, Klose, Houge, Ova, and Gumke voted aye. Martin voted No. Motion carried.

Lucas Dockter discussed changes to his proposal for the marina building at the Jamestown Reservoir. The proposed lease fee will change from \$600 to \$1,200 annually for 10 years. Dockter removed the request for the county to provide updates to the cooling system. Dockter requested that the county cover up to \$7,000 for a walk-in cooler no smaller than 6x6, and the cost of electrical installation. The county would also cover maintenance and repairs. Dockter would cover any cost over \$7,000. The cooler would be owned by the county. Houge is not in favor of allowing the Dockter the use of up to three campsites. Karl Bergh, Park Superintendent, suggested that a campsite be created near the park shop to allow Dockter's employees to camp. Bergh will work with Dockter to find a suitable area near the shop. Cichos made a motion to enter Dockter's proposal into a lease. Houge seconded. Cichos, Klose, Martin, Houge, Ova, Gumke, and Morris voted aye. Motion carried.

Dave Odin, from Dakota Anglers, proposed to partner with Stutsman County Park Board for a double ramp at the south end of the marina. Game & Fish estimated that it would cost around \$20,000. Game & Fish

would contribute 75% with the remaining \$5,000 being split between the county and Dakota Anglers. This will be discussed at future meetings.

Gene Vaneeckhout, Dakota Anglers, made a request that rocks to be pulled by boat club bay. Bergh said that he could try to remove as much as he can. They both will look into additional options as to how to remove the rocks.

Martin contacted Scott Alstead at Save Our Lakes. Alstead sent Martin a plan about rock jetties. Martin will get estimates for how much that will cost and bring it to a future meeting.

Cichos made a motion to approve the mid-month bills, seconded by Ova. Klose, Martin, Hogue, Ova, Gumke, Morris, and Cichos voted aye. Motion carried.
