

Official Proceedings of the Stutsman County Commission – November 17, 2020

At 8:00 a.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, David Schwartz, Steven Cichos (via phone), and Mark Klose answered the roll call. Ramone Gumke was absent.

Shannon Larson, Human Resource Director, discussed board appointments. She would like to advertise for a park board position since Joan Morris will be taking over as a Commissioner.

Corry Shevlin, JSDC, discussed a request for Flex PACE money. There have been several projects in the county outside of Jamestown city limits. They are requesting an additional \$68,000 to fund the remaining projects for 2020. Schwartz made a motion, seconded by Ova, to approve the request. Ova, Schwartz, Cichos, and Klose voted aye. Motion carried.

Jamison Veil, Jamestown City Assessor, presented two abatement applications. Parcel #74-2033000 applied for an abatement for 2018. They were previously granted an abatement for 2019. The apartment building was built too low and they are having issues with water and are currently in litigation with the engineering firm. They city council recommended approval. Cichos made a motion to approve the abatement, seconded by Ova. Schwartz, Cichos, Klose, and Ova voted aye. Motion carried.

Veil discussed an abatement for 2019 for Parcel #74-1972240. The value was adjusted for the 2020 tax year. The property was destroyed by a fire and has been gutted with the intention of remodel. The city council recommended approval. Schwartz made a motion to approve the request, seconded by Ova. Cichos, Klose, Ova, and Schwartz voted aye. Motion carried.

Mickey Nenow, County Highway Superintendent, presented a review of RFPs for Hwy 67 road projects. They received two proposals for the grade raises. Nenow proposed a committee of Dave Schwartz, Denny Ova, and himself to conduct interviews.

Schwartz made a motion, seconded by Cichos, to approve the mid-month bills. Klose, Ova, Schwartz, and Cichos voted aye. Motion carried.

Klose updated the board on the Auditor/COO position vacancy. They have not received any applications yet.

Official Proceedings of the Stutsman County Park Board – November 17, 2020

At 8:20 a.m., the County Park Board meeting was called to order. Dennis Ova, David Schwartz, Steven Cichos (via phone), Mark Klose, Joan Morris (via phone), and Jason Houge answered the roll call. Ramone Gumke was absent.

Karl Bergh, Park Superintendent, presented his bi-monthly report. All the seasonal workers are gone for the year. One dock is still in and he will leave it in until ice forms. Karl will be working on planning projects and finding funding over the winter. Bergh looked at a comparison between 2019 and 2020 with the change in the concessionaire at Pelican Point. Expenses paid by the Park department in electricity, water, sanitation, and supplies totaled \$19,000. We received \$11,799 in camping fees and \$1,606 in electricity expenses reimbursed. Overall, the county lost \$6,588 in 2019 at Pelican Point.

Permit fees for a cabin transfer for 32W were discussed. This is for a transfer that occurred in October and they requested a prorated fee. This was tabled at a previous meeting. There is also another transfer pending. This issue was tabled until the next meeting after the land transfer is finalized.

2021 cabin permit fees were discussed. Schwartz made a motion to extend the deadline for 2021 fees by 30 days, seconded by Houge. Houge, Morris, Ova, Schwartz, Cichos, and Klose voted aye. Motion carried.

Houge made a motion to approve the bills, seconded by Schwartz. Morris, Ova, Schwartz, Cichos, Klose, and Houge voted aye. Motion carried.
