Official Proceedings of the Stutsman County Commission

November 18, 2008

At 8:00 a.m., Chairman Klose called the mid-month meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, Doug Kaiser, Craig Neys and Mark T. Klose answered roll call.

Noel Johnson, County COO, reviewed the Township balances owed to the Road Department. The debt had decreased from \$721,000 to \$626,000. Johnson recommended placing excess levies on the Townships that were more than one year delinquent and over \$15,000. Neys made a motion that was seconded by Kaiser to place a 9 mill excess levy on the following townships: Corwin, Eldridge, Flint, Griffin, Roosevelt, Rose, Stirton, Wadsworth and Walters. Motion carried. All taxes collected from the excess levy would be applied to the respective Township's road department debt.

Mike Zimmerman, County Highway Superintendent, informed the Board of possible road funds that may be available from ND DOT. DOT had indicated that the funds could be one-half of the normal federal funds or about \$170,000. Plans for a road project would have to be submitted within 90 days of the notification of available funds. The funds would likely be used for a couple of chip sealing projects.

Zimmerman requested permission to advertise for bids for a front-end loader and a backhoe. Marks made a motion that was seconded by Ova to advertise for separate bids for a front-end loader and backhoe, a combined bid for both machines, bids with trade-in and bids for outright purchase of the used machines that were being replaced. Motion carried.

A motion was made by Kaiser and seconded by Neys to pay \$335.00 in taxable meals. Roll call vote – Ova, Marks, Kaiser, Neys and Klose voted aye.

Ova made a motion that was seconded by Kaiser to pay the mid-month bills. Roll call vote – Marks, Kaiser, Neys, Klose and Ova voted aye.
