

Official Proceedings of the Stutsman County Commission

December 15, 2009

At 8:00 a.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Dale Marks, Craig Neys, Doug Kaiser and Mark T. Klose answered roll call.

A motion was made by Ova seconded by Neys to reappoint Dale Marks to the JSDC Board of Directors. Motion carried.

Neys made a motion seconded by Kaiser to make to following appointments. Motion carried. Stutsman County Park Board – Bob Woodward and Mark Schlecht (3 year terms); Social Services – Lynn Tally (3 year term); Stutsman County Weed Board – Kim Lees and David Deutscher (4 year terms); Human Service Council – Sandy Bendewald (2 year term); and Buffalo City Tourism – Marlyn Bertsch (3 year term).

Duane Nester, Germana Township Supervisor Chairman, requested a \$10,000 loan for their township to help pay for a grade raise. The Township was not sure whether or not FEMA would reimburse them for the work. Kaiser made a motion seconded by Marks to approve the loan from the General Fund Sub-Account with a repayment deadline of May 1, 2012 and 5% annual interest. Roll call vote – Ova, Marks, Kaiser, Neys and Klose voted aye.

Noel Johnson, County COO, requested approval of the voting precincts for the 2010 Primary and General elections. Johnson considered reducing the Jamestown precincts from 6 to 2, but there was some concern about ballot rotation. He recommended the same precincts as the 2008 elections. Changes could be made after the 2010 census. Ova made a motion seconded by Marks to approve 6 rural and 6 Jamestown precincts for the 2010 elections. Roll call vote – Marks, Kaiser, Neys, Klose and Ova voted aye.

A motion was made by Neys seconded by Kaiser to approve the beer license application of Sandra Norquist d/b/a Ypsilanti Bar & Grill. Motion carried.

Karen Samek, County Recorder, introduced Cheryl McPherson. Cheryl was hired to fill the vacancy created by Dorothy Robyt's retirement.

Ova made a motion seconded by Kaiser to pay \$1,772.50 in taxable meals. Roll call vote – Kaiser, Neys, Klose, Ova and Marks voted aye.

Neys made a motion seconded by Kaiser to pay the mid-month bills. Roll call vote – Neys, Klose, Ova, Marks and Kaiser voted aye.
