Official Proceedings of the Stutsman County Commission –December 18, 2012

At 8:00 a.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Denny Ova, Dale Marks, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call.

Jim Fettig, Courthouse Maintenance Supervisor, requested approval to purchase a John Deere lawn tractor. Jim and Howie Peuser both budgeted approximately \$7,000 to purchase a lawn tractor. Jim informed the commissioners that he is starting a rotation system with Dennis Lorenz, County Park Superintendent. Jim has a lawn tractor that was purchased in 1985 and it needs to be replaced. Dennis has a lawn tractor that has approximately 1300 hours on it which will go to Jim. Jim will turn around and give Dennis his older used lawn tractor which has about 300 to 350 hours on it. The lawn decks will be switched to the new tractor and Jim will sell the oldest lawn tractor out right. The John Deere lawn tractor will cost around \$15,250.00 for the tractor, cab, and heat. In another three years they will look at rotating another lawn tractor. Neys made a motion, seconded by Schwartz for approval to purchase a lawn tractor as requested. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

Jim presented the board with three courthouse facility improvement grants. He budgeted approximately \$60,000.00 to do the following projects: tile the front area of courthouse lobby, eight doors need to be set up with the keyless entry and make the hallway to the judges secure; nine heat pumps need replacement; upgrade the elevator with electronic components; and purchase two new metal detectors. The grants are a 75/25 split with the county share being 25 percent. Jim will try to do as much as he possibly can which depends upon the approval of the grant. Ova made a motion, seconded by Marks to approve the grant applications and improvements as requested. Motion Carried.

Jim informed the commissioners that the Treasurer's Office purchased a new safe for the vault and they need to dispose of the old safe. The parts for the old safe are almost no longer available and it would cost more to open the safe if there was something inside of it. The Historical Society would like to have the old safe. The safe is approximately 4500 pounds and is made of magnesium. Ova made a motion, seconded by Neys to approve the Historical Society taking the old Treasurer's Safe providing that they do it in one week; otherwise, it will be taken out to West End for salvage. Motion Carried.

Dustin Bakken, Interim Tax Director, received an application for abatement or a refund of taxes for 2011 and 2012 in Ypsilanti Township, parcel number 64-0732509. Marks made a motion, seconded by Schwartz to approve the abatement as presented. Roll call vote: Marks, Schwartz, Neys, Klose, Ova voted aye.

Dustin presented an amendment for the wind turbine zoning ordinance. The language has been updated to provide maintenance and upkeep of township and county roads, what kind of timelines, as well as having financial security including a timeline of one year after the construction for companies to follow. On page five, paragraph F one change from the zoning committee did not get changed. It is supposed to read: "The agreement will contain provisions requiring the permittee to dedicate, bind, commit and/or pledge collateral, surety, escrow, and/or other pecuniary security for road maintenance and repair." Ova made a motion, seconded by Marks to approve the amendment to the Stutsman County Zoning Ordinance in relation to Wind Turbines including the change on page five, paragraph F as presented. Roll call vote: Schwartz, Neys, Klose, Ova, Marks voted aye.

Dustin reported to the commissioners that there was an omitted assessment for parcel number 62-2522022 in the amount of \$10,500 for the residential land value and \$30,800 for the building value. There was no change in the valuation of this property from last year. Schwartz made a motion, seconded by Neys to approve the omitted assessment for parcel number 62-2522022 as presented. Motion Carried.

Connie Ova, JSDC, requested the annual funding for SCDRC/SBDC for 2013 in the amount of \$33,810.00 which is a five percent increase from the 2012 dues. It is a 63/37 percent split between the city and the county with the county's portion being \$12,510.00. Discussion was held on whether or not the county should continue its membership with the South Central Dakota Regional Council (SCDRC). Neys made a motion, seconded by Schwartz to pay one fourth of the dues and reevaluate at the last meeting in March. Roll call vote: Neys, Klose, Ova, Marks, Schwartz voted aye.

Jim Diede requested the county commissioners to write a letter of support to John Thompson, NDDOT,

for additional turning lanes at the intersection of Highway 281 and Highway 36/Highway 52 at Pingree, North Dakota. Schwartz made a motion, seconded by Ova to write a letter of support for turning lanes northbound and southbound on Highway 281 at the intersection of Highway 281 and Highway 52 at Pingree, North Dakota as well as requesting a response back from the Department of Transportation. Motion Carried.

Ova made a motion, seconded by Neys to approve the request for the volume cap extension as requested. Motion Carried.

Schwartz made a motion, seconded by Marks to approve the right of way and utility certifications for the Spiritwood and Streeter grade raises. Interstate Engineering stated that there were no utilities that were affected. Motion Carried.

The right of way acquisitions were appraised by Noel Johnson. David and Bradley Klose right of way acquisitions were for parcel 3-1 for .83 acre, parcel 4-1 for 3.14 acres, and a temporary easement on parcel 4-2 for .21 acres for a total amount of \$13,590.00 and Mary and Lynn Greshik were for parcel 2-1 for .82 acre and parcel 8-1 for .10 acre for the amount of \$2,813.00. Neys made a motion, seconded by Marks to approve the right of way acquisitions as presented. Roll call vote: Klose, Ova, Marks, Schwartz, Neys voted aye.

Casey Bradley, Auditor/COO, presented information regarding a cell phone per diem increase. The Sheriff's Department pays for cell phones for the deputies. Some of the employees carry two cell phones. Currently, the county provides \$20.00 per month stipend to the employees that use their personal cell phones. Bradley proposed increasing to \$30.00 per month for voice access and \$50.00 per month for internet access. It is the consensus of the board to table the cell phone per diem request for all departments until the next meeting so the commissioners can gather more information.

Jerry Bergquist, 911 Coordinator/Emergency Manager, requested approval of an employee move from regular part-time status to regular full-time status. Ova made a motion, seconded by Schwartz to approve the request as presented. Motion Carried.

Bradley received a letter requesting an increase for the mental health compensation rate from \$75.00 to \$90.00 per hour. Some attorneys spoke with Judge Greenwood regarding the mental health compensation rate. Judge Greenwood directed the attorney's to speak with the county. Chris Iverson, State of North Dakota, stated that other counties are offering \$90 per hour. Bradley projected that the increase would be approximately \$27,000 and that \$30,000.00 was budgeted for 2013. Bradley spoke with Fritz and Fritz's opinion is that it should be tied to the indigent rate which is \$75.00. Schwartz made a motion, seconded by Neys to approve the increase for the mental health compensation rate to \$90.00 effective January 1, 2013. Roll call vote: Ova, Marks, Schwartz, Neys, Klose voted aye.

Ova made a motion, seconded by Schwartz to approve a beer application for Wayne and Hilda Kuntz d/b/a/ Sportsman Bar & Café. Motion Carried.

Schwartz made a motion, seconded by Ova to approve a beer application for Stutsman County Fair Association. Motion Carried.

Bradley followed up with the City of Jamestown and the city's position is that the Buffalo City Tourism Foundation Board will need to appoint their own board member. Marks made a motion, seconded by Ova to appoint Jason Houge and Robert Woodward to the Stutsman County Park Board. Motion Carried. Schwartz made a motion, seconded by Marks to appoint Lynne Tally to the Social Service Board. Motion Carried. Neys made a motion, seconded by Schwartz to appoint Clyde Reister, Dennis Clark, and John Schock to their current positions with Greg Spenningsby as an alternate for the Water Resource Board. Motion Carried. Stutsman County did not receive any applications for the Tuition Appeals Board. Bradley stated that he would contact Lary Olson to see if he would be on the Tuition Appeals Board.

Bradley updated the board with the response he heard back from Representative Rick Berg on the production tax credit extension. The letter thanked Stutsman County for their support of the tax credit and explained Rick Berg's involvement in the effort to extend the tax credit.

Chad Kaiser, Stutsman County Sheriff, requested an employee to receive a step increase for 2013. The policy in the employee handbook states that "An employee who is classified and assigned a grade and step in the existing Stutsman County pay plan and whose annual performance evaluation has an average overall score of three or higher will move to the next step, toward maximum." This went into effect January 1, 2006. The step increase will be effective January 1<sup>st</sup> of each year which went into effect in 2008 or 2009. The employee started August 3, 2012. Kaiser is requesting the employee receive a step increase effective August 1, 2013 pending a satisfactory annual review. Schwartz made a motion, seconded by Marks to approve the step increase request effective August 1, 2013 with a satisfactory evaluation. Motion Carried.

Commissioner Schwartz attended the Spiritwood Township meeting when the township voted to turn the GRE road over to the county. The landowners have some requests to have a noise ordinance prohibiting the exhaust brakes, some signage, and to sign the intersection to 25 mph. The road is currently 40 mph and should have no impact on any of the businesses in the area. Another request for signage prohibiting the use of exhaust brakes near the intersection 62 South was made as well. Schwartz made a motion, seconded by Marks to approve a noise ordinance and speed ordinance to 25 mph according to engineer specifications pending the right of way agreements. Motion Carried.

Marks made a motion, seconded by Neys to approve the taxable meals and mid-month bills for payment. Roll call vote: Marks, Schwartz, Neys, Klose, Ova voted aye.
