

At 8:00 a.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, David Schwartz, Craig Neys, and Mark T. Klose answered the roll call. Dale Marks was absent.

Casey Bradley, Auditor/COO, informed the board that Archer Company had conducted a review of several positions within the Law Enforcement Center, Sheriff's Office, and Auditor's Office. COO Bradley requested to change Josh Smaage's title to Director of IT based on the changes to his daily duties and position responsibilities. The last job description reviews were conducted in 2004 for many of these positions. The Personnel Committee is looking at instituting a rotation system to evaluate job positions for all departments based on a five year rotation. A motion was made by Neys and seconded by Ova to approve the position reclassifications as presented with the step increase for the administrative assistant commencing January 1, 2012. Roll call vote: Ova, Swartz, Neys, Klose, voted aye.

Swartz motioned to approve Josh Smaage title to Director of IT, Neys seconded the motion. Motion Carried.

Jerry Bergquist, 9-1-1 Coordinator/Emergency Manager, updated the board on the results of the ND State and Local Intelligence Center. Some of the recommendations will require time and a change in policies as well as some monies. There may be a possibility of some grant money available. Jerry Bergquist requested to do an assessment on the Social Services Building. The consensus of the Commission is to have an assessment done on the Social Service Building.

Toni Hible, Director of Tax Equalization, presented contracts to provide assessing services to Lippert and Eldridge Townships. A motion was made by Ova and seconded by Schwartz to enter into a contract to provide assessing services to Lippert and Eldridge Townships. Motion Carried.

A motion was made by Ova and seconded by Schwartz to accept the resignation of Interim Deputy Treasurer Lindell and appoint Lindsay Baumgartner as Interim Deputy Treasurer and Renee Valenta as Interim County Treasurer. Roll call vote: Swartz, Neys, Klose, Ova, voted aye.

A motion was made by Schwartz and seconded by Neys to approve the 2012 Primary and General Election Polling Locations as follows: Precinct 1 Pingree Community Center, Precinct 2 Kensal Memorial Hall, Precinct 5 Medina Memorial Hall, Precincts 3,4,6 Jamestown Civic Center, and City of Jamestown (J1 J6) Jamestown Civic Center. Motion Carried.

Jon Arnston from Arnston ,Stewart, Wegner PC presented resolutions to the board regarding the Public Finance Authority emergency funding program, which the county had applied previously. Mr. Arnston explained that the County was not obligated to pay any principal or interest costs until proceeds are drawn and that any draws would be for the amount need not the full amount approved. A motion was made by Schwartz and seconded by Ova to approve the authorizing bond resolution as presented. Roll call vote: Neys, Klose, Ova, Swartz, voted aye.

A motion was made by Neys and seconded by Schwartz to appoint Dale Reimers to the Weed Board for a term of four years, Anthony Roorda to the Water Resource Board for a term of five years, Rory Hoffmann to the Buffalo City Tourism Board for a term three years, Sandy Bendewald

to the Human Service Council for a term of two years and John Conway to the Social Service Board for a term of three years. Roll call vote: Klose, Ova, Swartz, Neys voted aye.

A motion was made by Neys and seconded by Schwartz to approve the taxable meals and the mid-month bills. Roll call vote: Ova, Swartz, Neys, Klose voted aye.
