

Official Proceedings of the Stutsman County Commission—December 21, 2021

At 3:30 p.m., Chairman Klose Called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Joan Morris, Steve Cichos, and Mark Klose answered the roll call. Ramone Gumke was absent.

Jamison Veil, Jamestown City Assessor, presented an abatement request for parcel # 74-6702000. The owner of the storage property is asking for a reduced value of \$325,000.00 compared to Veil's assessment of \$636,942. Four local storage units similar to this property sold for more than the assessment. Veil's request is to deny the abatement request.

Brian Meckler, MBS Storage LLC owner, does not think property is worth the assessed value. Choice Bank did an appraisal of the property and appraised it at \$420,000. Meckler says the business is not making money. Meckler's assumption was that the units were half full to 40%, and when the sale closed only about 25-30% were filled. Cichos made a motion to deny the request, seconded by Morris. Ova, Morris, Cichos, Klose voted aye. Motion carried.

Corey Genter, Tax Assessor, presented an abatement request for Parcel #72-9700230. Genter recommends reducing the true and full value of \$210,000 to \$170,900. Cichos made a motion to approve the request, seconded by Ova. Morris, Cichos, Klose, and Ova voted aye. Motion carried.

Shannon Larson, Human Resource Director requested to re-advertise the Park Board opening. Morris made the motion to approve, seconded by Cichos. Motion carried.

Larson requested the renewal of the EAP contract with the Village. The contract is for three years at the cost of \$4,920 annually ending in November 2024. Ova made motion to approve, seconded by Morris. Cichos, Klose, Ova, and Morris voted aye. Motion carried.

Larson presented the new job description for the Auditor position and the approval to appoint Jessica Alonge as Auditor/COO. Steve Cichos proposed the position start at a grade 26, step 3. Morris made a motion to approve the appointment at grade 26, step 3, and to remove the interim title, seconded by Cichos. Klose, Ova, Morris, Cichos. Motion carried.

Jessica Alonge presented the proposed precincts for 2022 elections. The proposal reduces the rural precincts from six to three and maintains six precincts within the city of Jamestown. Most of the city of Jamestown is in District 12, and a small portion of Jamestown is in District 29. Cichos made a motion to approve, seconded by Morris. Motion carried.

Alonge requested purchase of a mail opener before the end of 2021. The purchase price is \$1,926.00, with a five-year maintenance contract for \$276.00 per year. Cichos made motion to approve, seconded by Ova. Ova, Morris, Cichos, and Klose. Motion carried.

A motion to approve the beer and liquor licenses for 281 Stop, Stutsman Co. Fair, and Sportsman Bar was made by Morris, seconded by Ova. Motion carried.

At 4:28 p.m., the County Commission meeting recessed for the County Park Board meeting.

Official Proceedings of the Stutsman County Park Board—December 21, 2021

At 4:29 p.m., the Stutsman County Park Board meeting was called to order. Dennis Ova, Joan Morris, Steve Cichos, Mark Klose, and Jason Houge were present. Ramone Gumke and Robert Martin were absent.

Dave Odin from Dakota Anglers presented an updated proposal for a double ramp at the Marina. The ramp would cost \$40,000. ND Game and Fish would cover 75% of the costs. Dakota Anglers and Stutsman County would split the remaining 25% fifty-fifty. Morris made a motion to approve the project not exceeding \$5,000, seconded by Cichos. Morris, Cichos, Klose, Houge, and Ova voted aye. Motion carried.

A motion to approve cabin renewal permits for Heisler, Degen, and Hammer was made by Cichos, seconded by Ova. Motion carried.

Ova made motion to approve the mid-monthly bills, seconded by Cichos. Cichos, Klose, Ova, Houge, and Morris voted aye. Motion carried.
