

Official Proceedings of the Stutsman County Commission – September 7, 2021

At 3:30 p.m., Chairman Klose called the regular meeting of the Stutsman County Commission to order. Dennis Ova, Ramone Gumke (via phone), Joan Morris, Steven Cichos, and Mark Klose were present.

Morris made a motion to approve the minutes of the July and August 2021 meetings, seconded by Ova. Motion carried.

Sarah Frohlich, Jamestown Community Corrections, presented the 2022 contract. The LEC board approved a monthly fee increase from \$400 to \$500. Jamestown Community Corrections oversees individuals who are given community service by the courts. The number of community service cases has increased from 19 total in 2020 to 27 so far in 2021. Cichos made a motion to approve the increase, seconded by Ova. Ova, Gumke, Morris, Cichos, and Klose voted aye. Motion carried.

Daren Peterka, Interstate Engineering, gave an update on the right of way acquisition for the bridge project on 34th Street. They have agreements with all the landowners to sign a quit claim deed to the county. The project should be completed next summer.

Megan Carmichael, Assistant State's Attorney, discussed a proposed settlement agreement for the Bayview vs. Zinck tax foreclosure sale case. The original holder of a mortgage resold it to Bayview. The homeowner failed to pay property taxes. The county initiated a tax foreclosure but allegedly failed to notify the second mortgage holder, Bayview. At the tax foreclosure sale, the county sold the property to Felix Property Management. Bayview sued Stutsman County and Felix Property Management. The proposed settlement agreement obligates Stutsman County to pay 2/3 of the \$45,000 settlement. Stutsman's insurer, North Dakota Insurance Reserve Fund, will cover the county's cost. Carmichael conveyed that State's Attorney Fremgen recommended that the commission approve entering into the settlement. Cichos made a motion to approve the settlement, seconded by Morris. Gumke, Morris, Cichos, Klose, and Ova voted aye. Motion carried.

Chad Jackson, Jail Administrator discussed two out of state travel requests. Two staff will be attending a 24/7 monitoring program training in Denver September 12-14. On September 29-October 3 employees will be attending a Turnkey training in River Falls, Wisconsin. Morris made a motion to approve the travel requests, seconded by Ova. Motion carried.

Mickey Nenow, Highway Superintendent, gave his monthly report. They are graveling and replacing culverts on Township and County roads. The Medina project will be completed this week. He has budgeted for two motor graders in 2022, but he would like to advertise for them early because prices are going to increase in October. They would not receive the equipment until 2022. Morris made a motion to advertise for bids on two motor graders, seconded by Ova. Motion carried.

Nenow requested approval for out of state travel for the regional conference in Sioux Falls on October 19-21. Cichos made a motion to approve the travel, seconded by Ova. Motion carried.

Two asset forfeiture requests from the Drug Task Force were presented. Kara Brinster is paid 20% for Special Prosecutor's fees for work performed in the forfeiture cases. Gumke made a motion to approve, seconded by Ova. Motion carried.

Andrew Kirking, Emergency Manager/9-1-1 Coordinator requested approval for an out of state training in Minnesota for two dispatch employees on October 13. Ova made a motion to approve, seconded by Morris. Motion carried.

An application for a special event permit for the Corner Bar was presented. Cichos made a motion to approve, seconded by Ova. Motion carried.

Jessica Alonge, Interim Auditor/COO, discussed maintenance rates for services. Jim Fettig helped the Vet's Club with a project, and they are willing to pay for his time. There has not been a set rate in the past. Jim spent approximately five hours and other staff spent seven hours on the project. Alonge proposed Jim's time be billed at \$60 per hour and other staff at \$45 per hour. Cichos made a motion to approve the rates, seconded by Morris. Motion carried.

At 4:06 p.m., the Commission meeting recessed for the County Park Board meeting.

Official Proceedings of the Stutsman County Park Board – September 7, 2021

At 4:07 p.m., Chairman Klose called the regular meeting to order. Dennis Ova, Ramone Gumke (via phone), Joan Morris, Steven Cichos, Mark Klose, and Robert Martin were present. Jason Houge was absent.

A re-appraisal from Dakota Appraisal was presented for Lot 5, Block 1, Cabin Area A South, for \$35,000. It was previously appraised for \$40,000. Cichos made a motion to accept the re-appraisal, seconded by Gumke. Morris, Cichos, Klose, Martin, Ova, and Gumke voted aye. Motion carried.

A revised version of the Bureau of Reclamation/Stutsman County Special Use Permit was presented. The county will be able to keep funds from weed control. The Bureau removed a couple areas on the west side of the reservoir from the permitted region. Martin made a motion to approve the permit as presented, seconded by Ova. Cichos, Klose, Martin, Ova, Gumke, and Morris voted aye. Motion carried.

Karl Bergh, Park Superintendent, discussed a dock permit violation. The permittee had been keeping property on the beach by their dock which is not allowed in the permit. The dock owners were sent a letter and have since removed their property from the beach. Morris made a motion to revoke the dock permit for this season, and place the permittee on probation for the summer of 2022, where the permit can be revoked for any violation with no warning period. There was no second.

Bergh discussed winter storage rates for campers. The rate was previously \$150. The board would like to leave the rate at \$150.

Bergh discussed a free camping weekend for county employees. Bergh proposed September 17-18. They would reserve one side of the campground for county employees. Cichos made a motion to approve, seconded by Ova. Motion carried.

Ova made a motion to approve the monthly bills, seconded by Martin. Klose, Martin, Ova, Gumke, Morris, and Cichos voted aye. Motion carried.
